MEMORANDUM CIRCULAR

SUBJECT : PARTICIPATION TO CONFERENCE AND CONGRESS OF
IMPLEMENTING PARTNERS IN CIVIL REGISTRATION

The Philippine Association of Civil Registrars (PACR), Inc. will conduct a CONFERENCE AND CONGRESS OF IMPLEMENTING PARTNERS IN CIVIL REGISTRATION at the Caloocan City Sports Coliseum, Bagumbong, Caloocan City on November 12-16, 2018. The conference aims to provide knowledge-based civil registration capability building, updates on civil registration laws, rules and regulations, leadership training as well as a venue for interaction and networking with other officers/partners responsible for civil registration in the country. The delegates shall compose of civil registry personnel, punong barangays, barangay secretaries and officials, local sanggunians, attendants at birth, solemnizing officers and other implementing partners in civil registration.

Among others, the following subjects will be taken up during the activity:


1. Concretizing alliances and linkages on Civil Registration by all Implementing Partners by intensifying and expanding civil registration services throughout the country;
2. Formulating strategies and approaches to remedy gaps on civil registration in order to lay the groundwork for the Philippine Identification System and ensure the guarantee to the universal right to name and identity;
3. Identification of tools and standards for civil registration, extensive information dissemination to all citizens and efficient civil registration services;
4. Mapping out civil registration plans and programs for uniform implementation and efficient civil registration services;
5. Interface between Local Civil Registry personnel, local officials, and Implementing Partners in civil registration to address challenges and problems on civil registration, propose solutions and remedial measures to ensure equal access to civil registration;
6. Strengthening the support and participation of all local officials, barangay officials/ barangay secretaries on civil registration as mandated by law for the benefit of the Filipino people.

Relative thereto, all concerned local government unit functionaries and others concerned are enjoined to support and participate in the conference. The payment for registration fee, travelling, accommodation and other incidental expenses may be charged against local funds provided that it is within the purview of their respective Capability Development Agenda (DILG Memorandum Circular 2010-139 dated December 2, 2010) subject to the availability of funds and the usual accounting and auditing rules and regulations.
