1. Background

Pursuant to Executive Order No. 773, entitled, "Further Reorganizing the Peace and Order Council," duties and functions of the said Council include, but are not limited to, providing a forum for dialogue and deliberation of major issues and problems affecting peace and order.

2. Purpose

This issuance encourages the Regional Peace and Order Council (RPOC) Chairpersons and Head Secretariat in the Luzon Cluster, as well as all Mayors, Vice Mayors, Chairpersons for the Committee on Peace and Order of the Sangguniang Panglungsod/Bayan, Local Public Information Officers and Local Anti-Drug Abuse Council Executive Officers or Focal Persons in the National Capital Region (NCR) to participate in the said Summit.

3. Scope/Coverage

All Provincial Governors, City and Municipal Mayors and DILG Regional Directors in the Luzon Cluster, and all others concerned

4. Policy Guidelines

- 4.1. The RPOC of the National Capital Region (RPOC-NCR) will host a Peace and Order International Summit 2018, following the theme: **Stepping UP to the Challenges** on Peace and Order in the 21st Century.
- 4.2. The Summit will be held on October 29-30 at the Marquis Events Place, Bonifacio Global City, Taguig City.
- 4.3. This activity will bring together international experts and advocates on peace and order to discuss practices, emerging trends and challenges on peacebuilding and security.
- 4.4. The following are highly encouraged to attend:
 - 4.4.1. All RPOC Chairpersons;
 - 4.4.2. RPOC Secretariat Heads:
 - 4.4.3. Mayors and Vice Mayors in NCR;
 - 4.4.4. Chairpersons for the Committee on Peace and Order of the Sangguniang Panlungsod/Bayan concerned within NCR;
 - 4.4.5. Public Information Officers in NCR; and
 - 4.4.6. Local Anti-Drug Abuse Council Executive Officers or Focal Persons in NCR.
