THE OF **PARTICIPATION** IN DEPARTMENT TRANSPORTATION (DOTr) SPECIAL SESSIONS ON LOCAL PUBLIC TRANSPORT ROUTE PLANNING AND MANAGEMENT (LPTRPM)

In reference to Memorandum Circular No. 2018-39 dated March 22, 2018, enjoining Local Government Units to participate in a series of trainings relative to the preparation of Local Public Transport Route Plan (LPTRP) by the LGUs, those LGU representatives who failed to attend the previous trainings schedules are encouraged to participate in the next series of trainings to be conducted in three (3) clusters on the following schedule and venues.

Relative thereto, all concerned Provincial Governors, City Mayors and Municipal Mayors are hereby enjoined to:

> 1. send their participants i.e. one (1) staff each from the Offices of the (a) Planning and Development, (b) Engineering, (c) Traffic Management; and

2. allow the re-imbursement of travelling and accommodation expenses of said participants, chargeable against local funds, subject to availability, accounting and auditing rules and regulations.

The training is a live-out activity. Meals and snacks shall be provided by the LTFRB. Accommodation, travelling and other incidental expenses shall be charged to local government funds. Confirmation of participants shall be coordinated with the LTFRB Regional Offices, including updates on venues.

All DILG Regional Directors are hereby directed to immediately cause the widest dissemination of this Memorandum Circular.
