SUBJECT : 2nd NABPLO NATIONAL CONVENTION, TO BE HELD ON NOVEMBER 26-28, 2018 AT THE MARCO POLO HOTEL, DAVAO CITY

The National Association of Business Permits and Licensing Officers (NABPLO), in partnership with the Department of the Interior and Local Government (DILG), and the Department of Trade and Industry (DTI), will be conducting the 2nd **NABPLO National Convention** with the theme, "2018 NABPLO National Convention: Soar High Expanding Horizons towards Ease of Doing Business" on November 26-28, 2018 at the Marco Polo Hotel, Davao City.

With the recently enacted Republic Act No. 11032, otherwise known as the Ease of Doing Business and Efficient Government Service Delivery Act of 2018, this convention aims to support the law by strengthening and reinforcing the government's efforts and commitments in the promotion of transparency and efficiency in the delivery of government services. Also, it intends to provide an interactive venue that will discuss local and national government policies and its impact on the ease of doing business in the country.

In this connection, all City and Municipal mayors or their representatives together with their Business Permits and Licensing Office (BPLO) Heads are encouraged to participate in the abovementioned activity on official business. The payment of corresponding travelling and accommodation expenses, and registration fee of Ten Thousand Pesos (PHP 10,000.00) which cover costs of conference materials and meals for the three-day event, may be authorized, chargeable against local government funds, subject to the availability thereof, and to the usual accounting and auditing rules and regulations.
