**SUBJECT : SECOND MINDANAO CONGRESS OF THE NATIONAL
MOVEMENT OF YOUNG LEGISLATORS**

The National Movement of Young Legislators (NMYL) will be conducting its Second Mindanao Congress on June 15-17, 2018 at Ocean 101 Hotel, General Luna, Siargao Island, Surigao del Norte with the theme, Young Legislators: Stalwarts of Sustainable Tourism and Environmental Protection.

The goal of the said congress is to strengthen the league members' idealism and commitment to good governance in the performance of their tasks in their local governments, particularly in the field of legislation and policy development. It aims to provide an avenue to discuss strategies deemed to help address local development objectives, relating to the Sustainable Development Goals: (1) sustainable tourism towards promotion of economic prosperity and social justice; (2) environmental protection and conservation towards promotion of ecological balance; and (3) improved municipal health system towards promotion of good health and well-being. The said topics will also be contextualized to a discussion of the challenges and triumphs on local governance in island municipalities.

In view of the above, and upon the request of Councilor Marlon Paulo Alejandrino, National President of NMYL, all concerned Local Chief Executives are encouraged to allow the participation of their Vice-Governors, Vice-Mayors, Provincial Board Members, City/Municipal Councilors, including the Presidents of Liga ng mga Barangay, who are members of the NMYL in the above-mentioned activity, on official business.


The payment of applicable travelling expenses and registration fee, if any, to cover the cost of hotel accommodation, meals and congress materials, per participant, may be authorized in accordance with the provisions of COA Circular No. 2012-003 dated October 29, 2012, chargeable against available local funds and to the usual accounting and auditing requirements, and to all pertinent laws, and rules and regulations. Likewise, the participating local government officials are reminded of the provisions of DILG Memorandum Circular 2018-25 dated February 28, 2018, prohibiting local government officials and employees from entering, staying and/or playing at gambling casinos.

The NMYL National President shall submit to, through the Director of the Bureau of Local Government Supervision, the Secretary of the Interior and Local Government, an After-Activity Report within fifteen (15) days after the congress has been conducted, with the following prescribed format:

- I. Executive Brief;
- II. List of Participants;
- III. Output of Technical Sessions;
- IV. Issues and Agreements or Recommendations (if any);
- V. Total Fees Collected and Disbursed (if any); and
- VI. Appendices, if any.
