**GUIDELINES IN THE CONDUCT OF THE
LIGA NG MGA BARANGAY (LnB) CHAPTER ELECTIONS AT ALL LEVELS**

MEMORANDUM CIRCULAR No. 2018 - 90
Date: June 21, 2018

I. LEGAL BASES

- A. Article One, Chapter I, Title Six. Book III of the Local Government Code of 1991 provides that "there shall be an organized Liga ng mga Barangay (LnB) Chapters at the Municipal, City, Provincial and Metropolitan Political Subdivision levels which shall elect their respective officers and members".
- B. Sec. 3 of R.A. 10952 stipulates in part that "The Liga ng mga Barangay at the municipal, city, and provincial levels shall not later than July 31, 2018, conduct elections for *ex officio* positions in the sanggunians under the supervision of the Department of the Interior and Local Government".
- C. Sec. 2 of R.A. 10952 stipulates that "The term of office of the barangay and sangguniang kabataan officials elected under this Act shall commence at noon of June 30 next following their election..."

II. PURPOSE

This MC is issued to provide the following:

- A. Guide to concerned local officials and DILG field officers on their roles in the conduct of the Liga ng mga Barangay Chapter Elections at all levels.
- B. Updated forms and templates for the conduct of the LnB Chapter Elections.

III. COVERAGE

This MC shall cover all Provincial Governors, City/Municipal Mayors, Punong Barangays, Representatives of the Liga ng mga Barangay National/Regional/Provincial/City/Municipal Chapters, LnB Chapter Secretary, Presiding Officers of the Sanggunians, DILG Regional, Provincial and City Directors, City/ Municipal Local Government Operations Officers, ARMM Regional Governor, Philippine National Police and all others concerned.

IV. CREATION AND COMPOSITION OF COMMITTEES AND BOARDS

A. Nominations Committee

- 1. The incumbent LnB Chapter President with the concurrence of the incumbent board members shall create a Nominations Committee and shall appoint a Chairman and at least two (2) but not more than four (4) members from the general membership (all newly elected Punong Barangays [PBs]).

2. The Chairman and Members of the Nominations Committee shall not be eligible to run for office in their respective chapter, while serving as Chairman and Members of the Nomination Committee.
3. The Nominations Committee shall circularize to the general membership the composition and addresses of the members of the Nominations Committee, together with the notice of meeting (Form 1).

A. Registration and Credentials Committee

1. The incumbent LnB Chapter President shall chair the Registration/Credentials Committee with the chapter secretary and treasurer or in whose absence, those appointed in their stead, serving as member therein.

B. Election Committee

1. The incumbent LnB Chapter President, with the concurrence of the incumbent board members, shall appoint a Chairman and at least two (2) but not more than four (4) members from the general membership.
2. No chairman or member of the Election Committee shall be eligible to run for any office in the chapter wherein he/she is performing such duties.

C. Board of Canvassers

1. The incumbent LnB Chapter President with the concurrence of the incumbent board members, shall appoint a Chairman and two (2) members from the general membership.
2. The chairman and the members of the Board of Canvassers shall not be eligible for any office in his/her LnB Chapter.

D. Board of Election Supervisors (BES)

1. It shall be composed of DILG as the Chairperson and Four (4) members, preferably one from the COMELEC, one from the Local Parish Pastoral Council or Church Leader, one from the Department of Education and one from the different government agency/office or non-government organization (NGO) or people's organization (PO), as may be determined by each incumbent LnB Chapter Board concerned.
2. Its duties and responsibilities are as follows:
 - a. Resolve any controversies such as breaking tie through toss coin, application of neighborhood rule, appreciation of marked ballot and absolute adherence to compliance to all pre-requisites in an all or nothing rule that may rise during the election meeting of the local LnB Chapter;
 - b. Refer all post-proclamation electoral protests, which must be submitted in writing to the LnB National Office within twenty-four (24) hours from the close of the election for its review and provide the decision of which shall be final and executory.
 - c. If the situation warrants, call upon the *Philippine National Police (PNP)* for assistance to ensure the smooth conduct of the election.

V. CALENDAR OF ACTIVITIES (Annex H)

A. Component City and Municipal LnB Chapters

On June 25, 2018 (Monday) (Sec. 1.1 of Article I, LnB Election Code)

- ✓ The incumbent LnB Chapter President or in his/her absence, the next highest ranking incumbent LnB Officer, duly assisted by the C/MLGOO, shall send a written notice of meeting to the general membership, as well as the incumbent Liga Chapter Board Members for the purpose of forming the various committees and boards.
- ✓ The newly-elected PB shall personally receive the written notice, or in his/her absence, by other officials of the barangay. Said written notice shall notify him/her of the following:
 1. Date, Time, Place, and Agenda of the General Membership Meeting of the Chapter (Form 1)
 2. Date, Time, Place, and Agenda of the Election Meeting (Form 2)

On July 2, 2018 (Monday)

- ✓ The incumbent LnB Chapter President, duly assisted by the C/MLGOO, shall convene the Meeting for the formation and designation of the members of the Committees and Boards.

On July 9, 2018 - July 11, 2018

- ✓ The Nominations Committee, or the LnB Chapter Secretary, shall make available to the prospective candidates the candidacy forms (Form 3).
- ✓ It shall receive, in writing, Certificates of Candidacies before 5:00 PM of July 11, 2018.

On July 13, 2018 (Friday)

- ✓ The Nominations Committee shall determine and certify prior to the election as to the qualifications of the candidates in accordance with the LnB Constitution and By-Laws (CBL) and Election Code.
- ✓ It shall also post in the chapter office prior to the elections a list as to those candidates who have duly qualified for election to their respective offices.

On July 16, 2018, Monday (Synchronized Component City/Municipal Chapter Election)

- ✓ The Registration/Credentials Committee shall:
 - Take charge of the accreditation and registration of delegates to the election meeting.
 - Prepare and issue the necessary proof of presence of a quorum for the said meeting

- Prepare and issue the voter's credentials for election purposes, duly signed by the LnB Secretary and Treasurer and duly attested by the LnB Chapter President.
 - Render a report as to the number of voting delegates duly registered, certified and accredited.
- ✓ The Election Committee shall:
- Exercise supervision and control over the conduct of the election proper.
 - Proclaim the winning candidate as the duly elected officers and board members of the respective LnB Chapter, on the basis of the election results certified by the Board of Canvassers.
- ✓ The Board of Canvassers shall:
- Be responsible for the public canvassing and counting of the ballots cast and certifying the results as to the number of votes garnered by each candidate for each of the elective positions.
 - Submit to the Election Committee the results of the election using Form 7.
- ✓ The Board of Election Supervisors shall:
- Resolve any controversies such as breaking tie through toss coin, application of neighborhood rule, appreciation of marked ballot and absolute adherence to compliance to all pre-requisites in an all or nothing rule that may rise during the election meeting of the local LnB Chapter.
 - If the situation warrants, call upon the *Philippine National Police (PNP)* for assistance to ensure the smooth conduct of the election.

On July 20, 2018 (Friday)

- ✓ The C/MLGOO shall transmit the Certified True Copy of the Certificates of Canvass and Proclamation, minutes of the election meeting and other pertinent documents to the:
- Provincial or Metropolitan Chapters; and,
 - National Liga with office address at the Unit 1410 14th Flr., East Tower, Philippine Stock Exchange Centre, Exchange Road, Ortigas Center, Pasig City, Telephone Nos: (02) 687-1316, Email add: lnbnational@yahoo.com.ph

B. Provincial, Metropolitan, Highly Urbanized City and Independent Component City Chapters

On July 16, 2018 Monday (Sec. 1.2 of Article I, LnB Election Code)

- ✓ The incumbent LnB Chapter President or in his/her absence, the next highest ranking incumbent LnB Officer, duly assisted by the P/HUC Directors/CLGOO, shall send a written notice of meeting to the newly- elected PBs in Metropolitan/HUC/ICC and to the newly elected Presidents of the LnB CC and Municipal Chapters, as well as the incumbent LnB Chapter Board Members for the purpose of forming the various committees and boards.

- ✓ The newly-elected PB/LnB CC and Municipal Chapter President shall personally receive the written notice, or in his/her absence, by other officials of the barangay. Said written notice shall notify him/her of the following:

1. Date, Time, Place, and Agenda of the General Membership Meeting of the Chapter (Form 1)
2. Date, Time, Place, and Agenda of the Election Meeting (Form 2)

On July 23, 2018 (Monday)

- ✓ The incumbent LnB Chapter President, duly assisted by the P/HUC Director/CLGOO, shall convene the Meeting for the formation and designation of the members of the Committees and Boards.

On July 24, 2018 - July 26, 2018

- ✓ The Nominations Committee or the LnB Chapter Secretary shall make available to the prospective candidates the candidacy forms (Form 3).
- ✓ It shall receive, in writing, Certificates of Candidacies before 5:00 PM of July 26, 2018.

On July 27, 2018 (Friday)

- ✓ The Nominations Committee shall determine and certify prior to the election as to the qualifications of the candidates in accordance with the LnB Constitution and By-Laws (CBL) and Election Code.
- ✓ It shall also post in the chapter office prior to the elections a list as to those candidates who have duly qualified for election to their respective offices.

On July 30, 2018, Monday (Synchronized Provincial, Metropolitan, HUC and ICC LnB Chapter Election)

- ✓ The Registration/Credentials Committee shall:
 - Take charge of the accreditation and registration of delegates to the election meeting.
 - Prepare and issue the necessary proof of presence of a quorum for the said meeting
 - Prepare and issue the voter's credentials for election purposes, duly signed by the LnB Secretary and Treasurer and duly attested by the LnB Chapter President.
 - Render a report as to the number of voting delegates duly registered, certified and accredited.
- ✓ The Election Committee shall:
 - Exercise supervision and control over the conduct of the election proper.

- Proclaim the winning candidate as the duly elected officers and board members of the respective LnB Chapter, on the basis of the election results certified by the Board of Canvassers.
- ✓ The Board of Canvassers shall:
 - Be responsible for the public canvassing and counting of the ballots cast and certifying the results as to the number of votes garnered by each candidate for each of the elective positions.
 - Submit to the Election Committee the results of the election using Form 7.
- ✓ The Board of Election Supervisors shall:
 - Resolve any controversies such as breaking tie through toss coin, application of neighborhood rule, appreciation of marked ballot and absolute adherence to compliance to all pre-requisites in an all or nothing rule that may rise during the election meeting of the local LnB Chapter.
 - If the situation warrants, call upon the *Philippine National Police (PNP)* for assistance to ensure the smooth conduct of the election.

On August 3, 2018 (Friday)

- ✓ The DILG Provincial Director shall transmit the Certified True Copy of the Certificates of Canvass and Proclamation, minutes of the election meeting and other pertinent documents to the National Liga with office address at the Unit 1410 14th Flr., East Tower, Philippine Stock Exchange Centre, Exchange Road, Ortigas Center, Pasig City, Telephone Nos: (02) 687-1316, Email add: lnbnational@yahoo.com.ph

C. National and Regional Chapters

On August 3, 2018 – August 5, 2018 (Sec. 1.3 of Article I, LnB Election Code)

- ✓ The incumbent LnB National President, duly assisted by the National Barangay Operations Office (NBOO) of the DILG, shall send a written notice of meeting to the duly-elected Provincial, Metropolitan, Highly-Urbanized and Independent Component City Chapter Presidents, as well as the incumbent National LnB Board for the purpose of forming the various committees and boards.
- ✓ Said written notice shall include the following:
 1. Date, Time, Place, and Agenda of the General Membership Meeting of the Chapter (Form 1)
 2. Date, Time, Place (in Metro Manila), and Agenda of the Election Meeting (Form 2)

In case of the Municipality of Pateros in NCR, a written notice shall be sent to the elected chapter president to participate in the Regional LnB Chapter Election.

On August 7, 2018 (Tuesday)

- ✓ The incumbent LnB National President, duly assisted by the NBOO, DILG, shall convene the Meeting for the formation and designation of the members of the Committees and Boards.

On August 7, 2018 – August 8, 2018

- ✓ The Nominations Committee or the LnB Secretary-General shall make available to the prospective candidates the candidacy forms (Form 3).
- ✓ It shall receive, in writing Certificates of Candidacies before 5:00 PM of August 8, 2018.

On August 20, 2018 (Monday)

- ✓ The Nominations Committee shall determine and certify at least seven (7) days prior to the election as to the qualifications of the candidates in accordance with the LnB Constitution and By-Laws (CBL) and Election Code.

On August 27, 2018 (Monday)

- ✓ Arrival and registration of Delegates and Voting Presidents (Hotel in Metro Manila, TBA)
- ✓ The Nominations Committee shall post in the election venue a list as to those candidates who have duly qualified for election to their respective offices.

On August 28, 2018 (Tuesday)

- ✓ National Convention (To be announced)

On August 29, 2018 (Wednesday)

- ✓ LnB National and Regional Chapter Elections (Hotel in Metro Manila, TBA)

VI. DILG ROLES AND RESPONSIBILITIES

1. Supervise the conduct of the local LnB chapter elections;
2. Extend support, when necessary, in sending notice of the date, time and venue of the chapter elections;
3. Secure, for the use of the Liga, the needed ballot box, portable voting booths and writing board from the treasurer of the city, municipality or province where election is to be held, or if necessary, any adequate paraphernalia for the purpose;
4. Provide assistance, upon request of the National Liga or Chapter concerned, in arranging a suitable change of venue for the conduct of the elections of a particular Liga Chapter/level;

5. Upon recommendation of the Regional Director, the Provincial/City Director shall undertake appropriate actions based on situations obtaining from operational considerations on matters affecting the conduct of the Municipal/City Liga Chapter Elections.
6. All DILG Field Officers are hereby enjoined to disseminate this Memorandum Circular in their respective areas of jurisdiction and extend technical assistance to the Liga ng mga Barangay Chapters as may be necessary and appropriate.
