NATIONAL CONFERENCE OF LIBRARIANS IN CELEBRATION OF THE 60TH PUBLIC LIBRARY DAY

Memorandum Circular No. 2019-10
January 24, 2019



1.0 Background

- 1.1 In celebration of the 60th Public Library Day, the National Library of the Philippines (NLP), in collaboration with Puerto Princesa City Library (PPCL) and National Commission for Culture and the Arts – National Committee on Library and Information Services (NCCA-NCLIS), will hold a 4-Day National Conference of Librarians with the theme, “Libraries CLICK as Space for Customers, Learning and Research, Innovations, Community Engagement and Knowledge Creation”.
- 1.2 The conference aims to provide an avenue for: (1) sharing knowledge and trends on Customers, Learning and Research, Innovations, Community Engagement and Knowledge Creation; (2) sharing of best practices, and (3) conferring awards and recognition to deserving public librarians and library in-charge in the country.

2.0 Purpose

This circular encourages Local Government Units (LGUs) to support the National Conference of Librarians by way of sending participants to the said event.

All Provincial Governors, City and Municipal Mayors, DILG Regional Directors, ARMM Regional Governor, and all others concerned

- 4.2 The conference will be held at Citystate Asturias Hotel Palawan, South National Highway, Tiniguiban, Puerto Princesa City on March 18-21, 2019;
