The Eastern Samar State University, an academic pillar specializing in the discussion of global issues and concerns related to disaster risk reduction management will host the 6th International Conference on Integrative Disaster Risk Reduction Management (ICIDRRM) with the theme, "Resilience means Changing Lifestyle in a Changing Global Climate" on 3-5 September 2019 at the Teatro Ibabawnon, ESSU Main Campus, Borongan City.

The annual conference serves as a platform for government officials and non-government actors to discuss and share new knowledge on the field of disaster risk reduction management. The 6th ICIDRRM will focus on embracing resilience through changing lifestyles, policies, practices, and actions to combat the pernicious effects of climate change. In particular, this year's conference will tackle, among others, effective climate change adaption and mitigation strategies such as land use planning and use of alternative and renewable energy to limit global warming to safer levels.

In this regard, all Local Chief Executives may authorize participation of interested local government unit (LGU) functionaries, particularly Planning and Development Coordinators (PDCs) and Disaster Risk Reduction Management Officers (DRRMOs) in said conference on official business. The registration fee is Three Thousand Five Hundred Pesos (₱3,500.00) inclusive of conference kits, meals and snacks, certificate, and a tour to selected agroecotourism sites. The payment of registration fees, travelling, and related expenses may be authorized, chargeable against local funds, and the usual accounting and auditing rules and regulations.
