CHAPTER ELECTIONS AND REGIONAL ASSEMBLY ELECTIONS

FOR THE TERM 2019-2022

The Vice Mayors' League of the Philippines (VMLP), in consonance with Section 2 of their Election Policy and Guidelines provides for the holding of their provincial chapter and regional assembly elections.

In view of the above, and upon the request of its National President, Vice Mayor Donnabel Joy F. Mejia, for the term 2019-2022, the said elections will be conducted on the following schedule:

In view of the above, all City and Municipal Mayors are hereby encouraged to allow the attendance of their Vice Mayors to the said provincial chapter and regional assembly elections, on official business. Pursuant to Section 1 (b) of the VMLP's Election Policy and Guidelines (as Amended in December 5, 2018, Manila City) and Section 2(a), Article V of the League's Constitution and By-Laws (CBL), the payment of Term Membership Fee in the amount of Thirty Thousand Pesos (PhP30,000.00), travelling expenses and corresponding registration fee, the amount of which to be determined by the VMLP local chapter in coordination with VMLP National Office, and with approval from the concerned DILG Provincial and Regional Directors, including the costs of hotel accommodation, meals and other activity-related materials, per participant, may be authorized, chargeable against available local funds, in accordance with, and subject to applicable limitations prescribed in

COA Circular No. 2012-003 dated October 29, 2012, to the usual accounting and auditing requirements and to all pertinent laws, rules and regulations. Likewise, the participating local government officials are reminded of the provisions of DILG Memorandum Circular No. 2018-85 dated February 28, 2018, prohibiting local government officials and employees from entering, staying and/or playing at gambling casinos.

The VMLP National President shall submit to, through the Director of the Bureau of Local Government Supervision (BLGS), the Secretary of the Interior and Local Government, a Post-Election Report within fifteen (15) days after the said provincial and regional elections have been completed.
