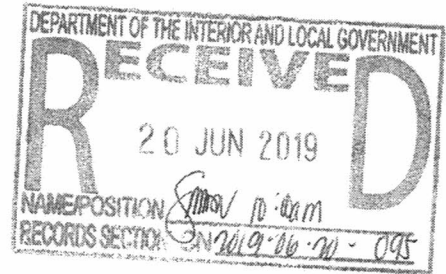


In view of this, we would like to respectfully request for your support through the issuance of a Memorandum Circular to encourage the Local Government Units to send SK Federation Presidents from their localities.

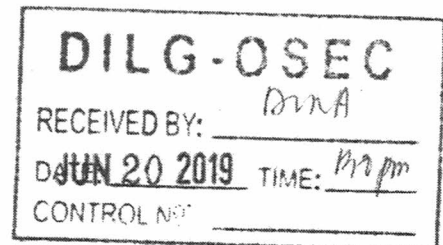
Please note that the organizers will provide the food and accommodation of the participants during the activity. However, travel and other incidental expenses shall be borne by the sending entities/offices.
