The LnB Mindanao Chapter will hold its **1**<sup>st</sup> **Mindanao Island Cluster Congress**, with the theme: "*Pinagbuklod ng Serbisyo pasa sa Matiwasay at Nagkakaisang Barangay*" on July 24-26, 2019 at the Waterfront Hotel, Cebu.

The activity is in line with the functions of LnB as an organization that gives priority to programs designed for the total development and promote the social, economic and political well-being of barangay officials in adherence to policies, programs and projects of the national government.

Also, the activity aims to develop the capacities of Barangay and Sangguniang Kabataan (SK) Officials to be able to provide an effective and efficient delivery of services to their constituents, among others.

In this regard, and upon the request of Hon. Edgar R. Sibuyan, LnB Vice President, Mindanao Chapter, all concerned Barangay and SK Officials are encouraged to participate in the said activity, on official business.

The payment of travel expenses and applicable registration fee of participants to cover the cost of meals and hotel accommodation, resource materials, may be authorized, chargeable against the barangay funds, subject to the availability thereof, and in accordance with the usual accounting and auditing requirements, and other pertinent laws, rules and regulations.

Further, all the participating Barangay and SK Officials are reminded of the following:

1. The travelling expenses and registration fee of participants shall not be chargeable against the 20% component of the Internal Revenue Allotment or from whatever source which may prejudice poverty reduction efforts; and

2. Entering, staying and/or playing at gambling casinos is strictly prohibited pursuant to the provisions of DILG Memorandum Circular 2018-25 dated 28 February 2018.

The LnB Chapter Presidents in Mindanao, are directed to submit a Post Activity Report to the Undersigned, through the Director of the National Barangay Operations Office (NBOO), within One (1) Month after the conduct of said Island Cluster Congress, with the following details:

- 1. Name/Title of the Activity;
- 2. Date and Venue;
- 3. Objective/s of the Activity;
- 4. Highlights of the Activity;
- 5. Outputs or Agreements;
- 6. Photo Documentation; and
- 7. Other applicable attachments.

All concerned DILG Regional Directors, BARMM Minister of Local Government and Field Officers are hereby directed to cause the immediate and widest dissemination of this Circular.
