MEMORANDUM CIRCULAR

ALL PROVINCIAL GOVERNORS AND REGIONAL GOVERNOR OF

SUBJECT

7TH REGIONAL COUNCIL ELECTIONS OF THE PROVINCIAL BOARD

MEMBERS LEAGUE OF THE PHILIPPINES (PBMLP)

Sections 1 and 2 of Article IX of the amended Constitution and By-Laws (CBL) of the Provincial Board Members League of the Philippines (PBMLP) provides for the conduct of a Regional Assembly which constitutes the regular and ex-officio members of the Provincial Board in each Region. Section 2b, Article XIV of said CBL provides for the conduct of the league's Regional Council Elections within one hundred fifty (150) days from the date of their assumption to office under a new term. For the term 2019-2022, the elections of new set of officers will be held within the months of August to September 2019.

In view of the above, and upon the request of Board Member Ferdinand P. Labung, Interim National President, PBMLP, all Provincial Governors are encouraged to allow their Provincial Board Members to attend the Regional Assemblies and elections in their respective Provinces on official business.

The payment of travelling expenses and applicable registration fee to cover the cost of meals and hotel accommodation, conference materials if any, including membership fee and term dues as provided in Article III, Section 3c of PBMLP's CBL may be authorized chargeable against local funds. subject to the availability thereof, and in accordance with the provisions of COA Circular No. 2012-03 dated October 29, 2012, and to the usual accounting and auditing requirements, and other pertinent laws, rules and regulations. Likewise, the participating local government officials are reminded of the provisions of DILG Memorandum Circular 2018-25 dated February 28, 2018. prohibiting local government officials and employees from entering, staying and/or playing at gambling casinos.

The PBMLP National President shall submit to, through the Director of the Bureau of Local Government Supervision (BLGS), the Secretary of the Interior and Local Government (SILG), a Post Election Report within fifteen (15) days after the completion of the league elections in every region.

PBMLP National Council Elections Resolution No.04 Series of 2016, Adopting the Guidelines in the Conduct of Elections of the Provincial Board Members League of the Philippines (PBMLP) is attached as an integral part of this Memorandum Circular.
