SUBJECT : THE 2030 PROJECT'S 4TH LEADERS UNITE: #AFTERHOURS

Republic Act No. 8044 otherwise known as the Youth in Nation-Building Act supports the principle of promoting and protecting the physical, moral, spiritual, intellectual, and social well-being of the youth to the end that the youth realize their potential for the improvement of the quality of life.

The 2030 Project is a non-profit, youth-led, and volunteer-based sustainable goals initiative in the Philippines composed of youth leaders from all over the country. It aims to create a network of youth leaders and youth-led organizations that develop advocacies and projects aligned with the United Nation's 17 Sustainable Development Goals (SDGs) Agenda by 2030.

The Leaders Unite is a one-day youth summit that aims to gather leaders advocating for the SDGs across the country. Every year, the summit features 17 exceptional youth champions in Luzon, Visayas, and Mindanao and is expected to be participated by 2000 youth leaders collectively. With the theme "Advancing the global goals through activation of everyday heroes," the event is being dedicated to student leaders, youth leaders, and young professionals who managed to create an impact in the community.

- IV. Issues and Agreements or Recommendations, if any;
