1.0 Background

- 1.1. Digitalization of MSMEs has been a priority in line with the Prosperity All Agenda in 2017. With the end goal of bringing about 70 to 80 million Filipinos to be part of the growing digital economy, it is vital to advocate for digitalization initiatives and digital platforms that create opportunities for micro and small entrepreneurs and enterprises related to tourism, and all the entrepreneurs in the informal economy.
- 1.2. In line with this, the Office of the Presidential Adviser for Entrepreneurship is organizing SIGN UP! (The biggest mobile app summit and expo in the Philippines Para sa Negosyo on September 23, 2019 Monday at the Halls A, B and C at the World Trade Centre, Pasay City. Registration starts at 7:00 AM.
