# 1.0 Background

- 1.1 Pursuant to the Memorandum Circular No. 56 dated January 25, 2019, issued by the Office of the President, directing all national government agencies and instrumentalities including the Government-Owned or Controlled Corporations and encouraging Local Government Units to extend their support to the Philippine Sea Games Organizational Committee Foundation Inc. in the preparation, organization and holding of the 30th Southeast Asian Games.
- 1.2 The Southeast Asian Games, otherwise known as the SEA Games, is a biennial multi-support event involving participants from the eleven countries of Southeast Asia Brunei, Cambodia, Indonesia, Laos, Malaysia, Myanmar, Singapore, Timor Leste, Thailand, Vietnam and Philippines.
- 1.3 The Philippine SEA Games Organizational Committee Foundation (PHISGOC) Inc., a non-stock, rion-profit organization, was created to oversee the preparations and the execution of the Philippine's hosting the 30<sup>th</sup> SEA Games this 2019.

### 2.0 Purpose

This circular encourages Local Government Units (LGUs) and all national government agencies and instrumentalities to support the conduct of the 30<sup>th</sup> SEA Games 2019.

#### 3.0 Scope/Coverage

All Provincial Governors, City and Municipal Mayors, DILG Regional Directors, BARMM Chief Minister, and all others concerned

#### 4.0 Policy Content and Guidelines

4.1 The 30<sup>th</sup> Southeast Asian Games will be conducted on November 30 to December 2019 in 54 competition venues scattered across four (4) venue clusters such as, Metro Manila, Clark, Subic and STL (Cavite, Batangas, Laguna and La Union).

- 4.2. All Local Chief Executives of various provinces, cities and municipalities that are hosting the games are hereby enjoined to extend full support by producing and displaying promotional material to be displayed along major thoroughfares within their respective LGUs in all streets in the immediate vicinity of all competition venues be dressed up as early as the month of September 2019 in order to increase awareness and support among locals.
- 4.3 To ensure the smooth and efficient organization and hosting of the 30<sup>th</sup> SEA Games, all LGUs, DILG Regional Directors and Field Officers are encouraged to lend their cooperation to the PHISGOC, Inc. in the preparation, organization and holding of the said activity in accordance with the existing laws and regulations.
- 4.4 All DILG Regional Directors are requested to cause the widest dissemination of this Memorandum Circular within their respective regional assignments.
