# 1.0 Background

- 1.1. Pursuant to Presidential Proclamation No. 837 s. 1991, the month of November of every year is Library and Information Services Month. This event is in recognition of the need to focus public awareness to the invaluable service that libraries and information centers render, i.e. providing data and materials for lifelong knowledge and learning, for research and for leisure.
- 1.2. For 2019, the National Commission for Culture and the Arts—National Committee on Libraries and Information Services (NCCA-NCLIS), the National Library of the Philippines, and the Philippine Librarians Association, Inc., will lead the celebration with the theme "Inclusive, Innovative, Interconnected" to highlight the important roles of libraries and information centers in building inclusive, innovative, and interconnected societies.

# 2.0 Purpose

2.1 This Memorandum Circular is issued to promote public awareness in the observance of 2019 Libraries and Information Services (LIS) Month Celebration to all and Local Government Units and DILG Offices.

- 4.1.3 Participation in the online campaign thread about the observabce by uploading photos, news, features and other information relative to LIS Month 2019 using the hashtag #LISM2019;
- 4.1.4 Uploading and sharing of LIS Month advocacy material in government agencies' website and social media accounts;
- 4.1.5 Featuring of the organization's Calendar of Activities and activity implementation reports and LIS Month 2019 advocacy materials in the official websites, social media accounts and publications. The link of the reports should be sent to NLP through Ms Chona S. Galo at cfsanpedro@nlp.gov.ph;
- 4.1.6 Announcement of Libraries and Information Services Month celebration in Flag Raising Ceremony of Government Offices (October 29, 2019);
