ATTENDANCE TO THE EASE OF DOING BUSINESS (EODB)

**FORUM ON NOVEMBER 14, 2019** 

Pursuant to the RA 11032, the Ease of Doing Business and Efficient Government Service Delivery Act of 2018 and in line with the government's campaign for enhanced competitiveness and simplification of requirements and streamlining procedures both in the national and local governments for business and non-business transactions, the DILG in partnership with the Department of Trade and Industry (DTI) and Department of Information and Communications Technology (DICT), in collaboration with the Anti-Red Tape Authority (ARTA), with the support of Union of Local Authorities of the Philippines (ULAP), National ICT Confederation of the Philippines (NICP), Microsoft Philippines and the United States Agency for International Development (USAID) will conduct the Ease of Doing Business (EODB) Forum 2019 on November 14, 2019 at The Manila Hotel, 1 Rizal Park, Ermita, Manila.
