MANAGEMENT (INREM 2019)

The University of the Philippines Los Baños (UPLB) through the Interdisciplinary Studies Center for Integrated Natural Resources and Environment Management (INREM) will hold the 2nd International Conference on Integrated Natural Resources and Environmental Management (INREM 2019) on 20-22 November 2019 at the Philippine International Convention Center (PICC), Pasay City, Metro Manila.

With the theme, 'Strengthening Local Governance for Sustainable Integrated Natural Resources and Environment Management', the three-day conference serves as a venue for academe. researchers, and practitioners in environment and natural resources management to share their knowledge and experiences on mainstreaming INREM in local governance and sustainable development. Themes to be tackled during the event include: lake and river basin; landscapes and seascapes; small islands; rural-urban areas linkages focusing on policy and governance, socio-economic analysis, biophysical assessment, pollution and environmental degradation. waste management, human settlements, indigenous knowledge system, common pool resources, and ecosystem-based adaptation and disaster risk reduction.

The conference provides an opportunity for local governments to present their INREM-related experiences and programs as well as learn from other LGU initiatives related to natural resources management. Likewise, it will also help initiate and/or reinforce partnerships and collaboration with other LGUs in strengthening integrated natural resources management in the country. As such, local government units are encouraged to participate in the said activity.

The organizers have only allotted forty (40) slots for participants coming from local government units. As such, please be advised that only the first forty (40) LGU representatives that expressed interest and confirmed their participation will be accommodated. For confirmation of participation, interested participants are required to fill-out the attached registration form to be sent through e-mail at inrem.uplb@up.edu.ph on or before 15 November 2019. Walk-in participants will not be entertained.

Registration fees and food for two days (November 20 and 21) of the participants will be shouldered by the organizers. However, transportation, accommodation, and other related expenses shall be charged against the funds of their respective offices subject to the usual accounting and auditing rules and regulations.
