Provided, however, that the travelling expenses and registration fee shall not be charged against the 20% component of the Internal Revenue Allotment or from whatever source which may prejudice poverty reduction efforts.

The LnB-Vice President for Mindanao shall submit within one (1) month after the conduct of the Assembly, a Post-activity Report to the Undersigned, through the National Barangay Operations Office, reflecting the following:
