7th PHILIPPINES TRANSFORMATIVE APPROACHES TO

INNOVATIVE LEADERSHIP (TRAIL) SUMMER CAMP ON 24-

28 APRIL 2019

Republic Act No. 8044 otherwise known as the Youth in Nation-Building Act supports the principle of promoting and protecting the physical, moral, spiritual, intellectual, and social well-being of the youth to the end that the youth realize their potential for improving the quality of life.

The Youthlead Philippines (YLP) in partnership with the United Nations Sustainable Development Solutions Network, City Government of Tagbilaran, Provincial Government of Bohol, and ABS-CBN will hold the Seventh Philippines Transformative Approaches to Innovative Leadership (TRAIL) Summer Camp on 24-28 April 2019 at Bohol Plaza Resort, Barangay Mayacabac, Dauis, Panglao Island, Bohol.

Primarily, the five-day camp serves as the capacity development component and bridging activity of the Philippines I Transform! Young Leaders Convention that influence and empower youth and adult leaders to think, work, and act together and make them active stakeholders in the advocacy and localization of the United Nations Sustainable Development Goals (SDGs). It further seeks to equip youth leaders and adult leaders with the right skills and values to make their leadership more meaningful and dynamic using transformative approaches.

In view of the above, all local chief executives are hereby encouraged to allow on official business the participation of their Sanggunian Kabataan officers and members including LYDC members to the abovementioned activity.

The payment of registration fee in the amount of **Eight Thousand Six Hundred Fifty Pesos (Php 8,650)** per participant to defray the costs of venue, meals and snacks and materials, and applicable travel expenses may be authorized chargeable against local funds, subject to the availability thereof, and to the usual accounting and auditing requirements and to all pertinent laws, rules and regulations.

The YLP shall submit a post-activity report to the DILG Secretary, through the National Barangay Operations Office (NBOO), within a month after the conduct of the said activity, with the following prescribed format:

- I. Executive Brief;
- II. List of Participants;
- III. Outputs of Technical Sessions;
- IV. Issues and Agreements or Recommendations, if any;
- V. Total Fees collected and Disbursed: and
- VI. Appendices, if any.
