1.0 Background

- 1.1 Under Republic Act of 8491, otherwise known as, "Flag and Heraldic Code of the Philippines" or the Flag Law, declares under Section 2, that reverence and respect shall at all times be accorded the flag, the anthem, and other national symbols which embody the national ideals and traditions, and which express the principles of sovereignty and national solidarity.
- 1.2 The National Heritage Commission of the Philippines (NHCP), in partnership with the Pronove Tai International Property Consultants will take lead celebration that promotes "Stop and Salute" by holding simultaneous public-private sector flag raising ceremonies in all national government agencies and local government offices and by displaying Philippine Flag in all buildings, streets and residential homes and villages are also encouraged.

2.0 Purpose

3.0 Scope/Coverage

All Provincial Governors, City Mayors, Municipal Mayors, DILG Regional Directors, and all others concerned

- 4.1. All Local Government Offices and DILG Offices are enjoined to undertake the following suggested activities conduct simple but meaningful commemorative activities such as:
 - 4.1.1 Proper display of new flags in all offices and premises nationwide in accordance to the Heraldic Code;
 - 4.1.2 Conduct simultaneous flag- raising ceremony on May 28, 2019, at 8:00 o'clock in the morning, including the recital of Pagpupugay (file to be provided by Pronove Tai International Property Consultants)

- 4.1.3 Display Stop and Salute Poster in their respective bulletins, billboards, and LED boards; and
- 4.2.3 Share DILG's "Stop and Salute" photos on social media #SaluteToACLeanFlag.
- 4.2 All DILG Regional Directors are likewise hereby request to cause the widest and immediate dissemination of this issuance to all local government units within their jurisdictions and ensure strict compliance thereof.
