MEMORANDUM CIRCULAR
NO. 2020-001

TO : ALL CITY MAYORS, MUNICIPAL MAYORS, DILG REGIONAL DIRECTORS, BARMM MINISTER OF LOCAL GOVERNMENT, AND OTHERS CONCERNED

SUBJECT : 24TH NATIONAL CONVENTION AND ELECTION OF THE NATIONAL EXECUTIVE COMMITTEE OF THE NATIONAL MOVEMENT OF YOUNG LEGISLATORS (NMYL)

Section 1, Article III of the NMYL-CBL provides that all elected and appointed vice-governors, vice-mayors, board members and city and municipal councilors who are 40 years old and below at the time of their election to office on May 13, 2019, shall automatically become members of the League.

Paragraph 3, Section 2, Article X further provides that election of officers of the National Executive Committee shall be held using an automated election system coinciding with the League's Annual Convention, which shall be held in the month of February following the conclusion of the Provincial and Regional Assembly Elections.

For the term 2019-2022, the election of the League's new set of national officers will be held during the League's 24th National Convention, scheduled on February 18-20, 2020 at the Waterfront Hotel, Lahug, Cebu City.

In view of the above, and upon the request of Atty. Enrique V. Dela Cruz Jr., Interim National President, NMYL, all Local Chief Executives are encouraged to allow their Vice-Governors, Vice-Mayors, Board Members, City and Municipal Councilors including Presidents of Liga ng mga Barangay and Sangguniang Kabataan Federation, to attend the said election, on official business.

The payment of applicable traveling expenses, and registration fee, if any, to cover the cost of hotel accommodation, meals and activity materials, per participant, may be authorized chargeable against available local funds, in accordance with, and subject to applicable limitations prescribed in COA Circular NO. 2012-003 dated October 29, 2012, to the usual accounting and auditing requirements and to all pertinent laws, rules and regulations. Likewise, the participating local government officials are reminded of the provisions of DILG Memorandum Circular No. 2018-25 dated February 28, 2018, prohibiting local government officials and employees from entering, staying and/or playing at gambling casinos.

The NMYL Interim National President shall submit a Post-Activity Report to the Secretary of Interior and Local Government, through the Director of the Bureau of Local Government Supervision, within fifteen (15) days after the conduct of the said activity, with the following prescribed format:

- I. Executive Brief;
- II. List of Participants;
- III. Outputs of Technical Sessions;
- IV. Issues and Agreements or Recommendations, if any;
- V. Total Fees and Disbursements; and
- VI. Appendices, if any.
