MEMORANDUM CIRCULAR

TO : ALL PROVINCIAL GOVERNORS, CITY MAYORS, MUNICIPAL MAYORS, BARMM MINISTER OF LOCAL GOVERNMENT, DILG REGIONAL DIRECTORS AND OTHERS CONCERNED

SUBJECT : AREA ELECTIONS FOR THE TERM 2019-2022 OF THE LADY LOCAL LEGISLATORS LEAGUE OF THE PHILIPPINES, INC. (FOUR-L)

Article XV, Section 5 of the Constitution and By Laws of the Lady Local Legislators' League of the Philippines (FOUR-L Philippines), Inc., provides for the conduct of their Regional, Provincial, District, City and Municipal Chapter elections.

Further, FOUR-L Resolution No. 012-2020 entitled, **Resolution to Reschedule the Area Elections for Provincial, District, City, and Municipal Chapter Presidents and Other Officers**, authorizes the conduct of Area Elections from February 10 to March 6, 2020 per province, in a region, and hereto attached as Annex A.

In view of the above, and upon the request of Board Member Nena G. Atimosa, Province of Davao de Oro and Interim FOUR-L National President, all Provincial Governors, City and Municipal Mayors are enjoined to allow all their lady local legislators to attend the said area elections, on official business.

The payment of Two Thousand Pesos (Php2,000.00) as Membership Fee and Three Thousand Pesos (Php3,000.00) as annual dues, travelling expenses, applicable registration fees, if any, per participant, may be authorized, chargeable against local funds, in accordance with, and subject to applicable limitations prescribed in COA Circular No. 2012-003 dated October 29, 2012, to the usual accounting and auditing requirements and to all pertinent laws, rules and regulations. Likewise, the participating local government officials are reminded of the provisions of DILG Memorandum Circular No. 2018-85 dated February 28, 2018, prohibiting local government officials and employees from entering, staying and/or playing at gambling casinos.

The FOUR-L National President shall submit to, through the Director of the Bureau of Local Government Supervision, the Secretary of the Interior and Local Government, a Post-Election Report within fifteen (15) days after the completion of the league elections as the provincial, city and regional levels.

Provided finally that, FOUR-L Resolution No. 011-2020 entitled, **Resolution Approving the Guidelines for the Area Elections for Regional, Provincial, District, City and Municipal Chapter Presidents and Other Officers** approved last January 16, 2020, insofar as they refer to the league election, shall be construed as integral part of this Department issuance.
