MEMORANDUM CIRCULAR

SUBJECT: ATTENDANCE TO THE KATARUNGANG PAMBARANGAY (KP) ONLINE TRAININGS

The Department of Justice (DOJ), through the Office for Alternative Dispute Resolution (OADR), in collaboration with the Department, will conduct the Katarungang Pambarangay Trainings for CY 2020, under the Justice Sector Coordinating Council (JSCC) in identified Justice Zones, namely, Angeles City, Bacolod City, Davao City, Naga City and Quezon City.

Due to the health risk brought about by COVID-19 pandemic, the KP trainings will be conducted through a series of short webinars, in lieu of a full online course on KP, which will include relevant procedural safeguards, Alternative Dispute Resolution (ADR) Skills and Techniques, the role of ADR and KP amidst COVID-19 Pandemic and discussion on the pressing KP issues and concerns.

In this connection and upon request of DOJ-OADR, all Punong Barangays, Sangguniang Barangay Members, preferably the Committee

Chairpersons on Women and Family, and Peace and Order, Barangay Secretaries, Members of the Lupong Tagapamayapa, Chief Executive Officers, Barangay Tanods, VAW Desk Officers, and representatives of the Local PNP are encouraged to attend the online trainings.

Further, Barangay and local officials outside of the identified Justice Zones are likewise encouraged to attend the KP online Training.

The series of KP online training shall be **FREE OF CHARGE** and Certificates will be issued by DOJ-OADR to the participants. For registration, confirmation of attendance, schedules of KP online trainings and log-in details, all concerned are directed to send their **full name, position/designation, barangay or Office, copy of their identification card, and contact details** to **info.oadr@gmail.com** not later than 30 July 2020.

All City and Municipal Mayors are encouraged to support the activity and may provide the barangay officials within its territory with the necessary assistance, such as internet connection, laptop, LCD, venue, among others which may deem necessary for them to attend and participate in the KP online trainings **taking into consideration the mandatory wearing of face mask and the strict observance of social distancing protocols by all the participants.**

All Regional Director and BARMM Minister of Local Government are enjoined to:

1. Require the KP Focal Persons at the Regional, Provincial, City and Municipal Levels to register and attend the online training.
2. As much as practicable, the KP Focal Persons of HUCs/ICCs and the C/MLGOOs should have the same online training schedule/s with their respective barangay officials.
3. Direct the Field Officers to inform the concerned Local Chief Executives and Local PNP on the matter.
4. Through the field officers, ensure attendance of the concerned barangay officials.
5. Submit a Regional Consolidated Monitoring report to the undersigned within 30 days after the preferred scheduled online training, with the following details.
