SUBMISSION OF SK, LYDO and LYDC DATA UPDATES

**FOR THE YEAR 2020** 

The National Youth Commission (NYC), in its thrust to fully implement Republic Act No. 10742 or the SK Reform Act of 2015, shall consistently monitor the compliance of Local Government Units to the aforementioned law.

In this connection, and through the request of Hon. Ryan E. Enriquez, Chairperson and Chief Executive Office of NYC, all SK Officials, together with their respective LYDOs, shall submit to NYC the following documents:

- Updated directory of all LYDOs under your jurisdiction, including contact details, such as, contact numbers, official e-mail address, and their status of appointment, (whether appointed or designated);
- Updated directory of all SK Pederasyon Presidents under your jurisdiction including contact details, such as contact number, official email address, and the status of their Local Youth Development Plan (LYDP) and a copy of their LYDP;
- 3. Directory of SK Officials from each Barangay with contact details, such as, contact number, and official e-mail address;
- 4. List of LYDC members, whether YORP registered or not, including name of focal person and their contact details, such as contact number, and official e-mail address; and

- 5. Copy of the Accomplishment Report for initial monitoring.

  NYC already sent e-mails to the current database-registered e-mail addresses of SK Officials. The officials concerned may update the details of SKs, LYDOs, and LYDCs by using the downloadable templates from the following directory links:
