RESOLUTION NO. 2020-029-A

September 9, 2020

RESOLUTION INDORSING THE REQUEST FOR ESCALATION OF GENERAL SANTOS CITY FROM MGCQ TO GCQ STATUS SUBJECT TO CONFORMITY WITH THE POLICIES SET FORTH BY THE NATIONAL IATF UNDER THE GCQ

WHEREAS, Per IATF Resolution No. 66 dated August 27, 2020, Beginning September 1, 2020, the Provinces of South Cotabato, Sarangani, Sultan Kudarat and Cotabato, HUC General Santos and ICC Cotabato were placed under the Modified General Community Quarantine (MGCQ) until September 30, 2020.

It further provides for the continuation of Community Quarantine classification for provinces, HUCs and ICCs as of September 1-30, 2020, unless circumstances signal the need for **escalation or if applications for de-escalation are submitted are submitted and approved**. The use of new parameters for escalation of risk classifications are the 1) Health Care Utilization Rate (HCUR); and 2) Equipment for COVID-19;

WHEREAS, per DOH COVID-19 Tracker, as of September 8, 2020, Region XII recorded a total of **677 confirmed cases**. Based on DOH data, in a span of one (1) week from September 2, 2020 – September 8, 2020, the Region recorded an increase of **two hundred fifteen (215) COVID-19 cases**, which is equivalent to an average of **30.71 cases per day**.

At present, General Santos City has a total of **131** COVID-19 cases, **76** active cases and **6** deaths. For the period September 1-8, 2020, it has recorded an increase of 47 cases and 5 deaths. Confirmed cases in 1st week of September 2020 is almost **600% higher** than the same period last August 2020;

WHEREAS, due to the confirmed local transmission and continuing increase of the COVID-19 cases in the City of General Santos and its neighboring LGUs, the City Government, in its letter-dated September 8, 2020, has requested for the RIATF's recommendation to the National IATF to change its quarantine classification from MGCQ to GCQ;

WHEREAS, after thorough deliberation and taking into account the existing health system of the City, where: a) Hospital Beds @ 52.6% occupancy rate; b) TTMFs @ 34.2% utilization rate; and c) having only 224 DOH Trained Contact Tracers. Its ratio of **1:45** population is over considering the **1:30** National Standard. These data on hand prompted the Body and agreed to indorse the City's request to the National IATF for consideration and approval;


NOW, THEREFORE, on motion of RD AKMAD J. USMAN, CESO IV of DBM XII and duly seconded by RD TERESITA SOCCORO C. RAMOS of NEDA XII, **BE IT RESOLVED, AS IT IS HEREBY RESOLVED** to Indorse to the National IATF the Request for Escalation of General Santos City from MGCQ to GCQ Subject to Conformity with the Policies Set Forth by the National IATF under the GCQ;




