**RESOLUTION NO. 2020-031**

September 23, 2020

**POLICY GUIDELINES AND RECOMMENDATIONS RELATIVE TO THE MANAGEMENT OF  
CORONAVIRUS DISEASE (COVID-19) SITUATION IN REGION 12**

**WHEREAS,** Per OMNIBUS GUIDELINES ON THE IMPLEMENTATION OF COMMUNITY QUARANTINE IN THE PHILIPPINES *with Amendments as of July 16, 2020*, the IATF approved the Implementation of the Modified Enhanced Community Quarantine (MECQ) including the zoning concept, corresponding qualification, and its phased response or intervention;



As of September 2, 2020, Region 12 being placed under Modified General Community Quarantine (MGCQ) status, have to strictly observe the following, to wit:

- **Minimum public health standards** shall be complied with at all times for the duration of the MGCQ;
- **The movement of all persons shall be limited to accessing essential goods and services, for work in the offices or industries permitted to operate hereunder,** and for other activities permitted under this Section. *(As amended by Paragraph A(4)(a) of IATF Resolution No. 43, June 03, 2020);*
- Mass gatherings such as but not limited to, movie screenings, concerts, sporting events, and other entertainment activities, religious services, and work conferences shall be allowed provided that participants shall be limited to fifty percent (50%) of the seating or venue capacity. *(As amended by Paragraph A(4)(d) of IATF Resolution No. 43, June 03, 2020)*

**WHEREAS,** IATF Resolution No. 66, pursuant to the recommendations of the IATF Sub Technical Working Group on Data Analytics approves the following:

- The continuation of the Community Quarantine classifications for Provinces, HUCs and ICCs as of September 1-30, 2020, unless the circumstances signaled the need for escalation of if applications for de-escalation are submitted and approved;
- Section 2 of the afore-cited Resolution also approved that beginning September 1, 2020, the following provinces, HUCs and ICCs shall be placed under Modified General Community Quarantine until September 30, 2020, without prejudice to the declaration of localized Enhanced Community Quarantine as follows:

For Mindanao:

*Region XII: North Cotabato; South Cotabato; Sarangani; Sultan Kudarat; General Santos City and Cotabato City*

**WHEREAS,** As of September 23, 2020, DOH XII COVID-19 Tracker revealed that the Region has a total of **1,201 confirmed cases**. There is an increase of **two hundred twenty three (223) COVID-19 cases** for a span of one (1) week, which is equivalent to an average of **31.86 cases per day**.

**WHEREAS,** with the increasing COVID-19 cases in the region, concerns regarding the capacity of health care systems of some LGUs, availability of contact tracers, absence of Contact Tracing Systems in areas affected and the inadequacy of temporary treatment monitoring facilities (TTMFs) were raised for consideration; hence, the Body concurred the following:

- Requests of five (5) LGUs for "Localized Lockdown", namely:
  - *Identified Households of Sitio Basac, Barangay Malandag, and Sitio Crossing Coronado, Barangay Malalacogon, Malungon, Sarangani on September 20-October 4, 2020;*
  - *Selected areas of Barangay Tina, Barangay D. Ledesma, and Barangay Griño, Tacurong City, Sultan Kudarat on September 17- October 1, 2020;*





- *Purok Orchids, Malipayon, and Santan of Barangay Cadiz, Kalamansig Sultan Kudarat on September 22, 2020;*
- *Purok Golden Coconut, Anggie Subdivision, Barangay Poblacion, Kidapawan City, Cotabato on September 18, 2020 – October 1, 2020;*
- *Purok Quezon, Barangay Naci, Surallah, South Cotabato on September 16 – 30, 2020.*

**WHEREAS,** Executive Order No. 70 s. 2018 was issued by President Rodrigo R. Duterte institutionalizing the Whole-of-Nation Approach to end insurgency in the country by 2022. One of the major activities under the said EO is the conduct of Local Serbisyo Caravan, which is an immediate response of all offices, with packages of social services to the affected communities to address basic services needs. For CY 2020, Region 12 has 103 target barangays, 63 of which are from the Province of Cotabato.

On September 16, 2020, the Cotabato Provincial Task Force on ELCAC requested the DILG to allow the conduct of Lokal Serbisyo Caravans for the 4<sup>th</sup> Quarter of 2020 in the 21 target barangays subject to strict compliance to health protocols;

**WHEREAS,** during the Joint RIATF-EID XII and RTF COVID-19 Meeting, the Body discussed, strategized and resolved emerging local issues and determined appropriate and future actions to avoid the further spreading of the virus given the foregoing premises;

**NOW, THEREFORE, BE IT RESOLVED,** as it is hereby resolved, that the Joint RIATF-EID XII- RTF-COVID-19 approved the following Resolutions:

- A. RESOLUTION CONCURRING THE LOCALIZED LOCKDOWN OF THE FOLLOWING LGUs SUBJECT TO SUBMISSION OF REQUIRED DATA/DOCUMENTS AS STIPULATED THEREIN, VIZ:
- *Identified Households of Sitio Basac, Barangay Malandag, and Sitio Crossing Coronado, Barangay Malalacogon, Malungon, Sarangani on September 20-October 4, 2020;*
  - *Selected areas of Barangay Tina, Barangay D. Ledesma, and Barangay Griño, Tacurong City, Sultan Kudarat on September 17- October 1, 2020;*
  - *Purok Orchids, Malipayon, and Santan of Barangay Cadiz, Kalamansig Sultan Kudarat on September 22, 2020;*
  - *Purok Golden Coconut, Anggie Subdivision, Barangay Poblacion, Kidapawan City, Cotabato on September 18, 2020 – October 1, 2020;*
  - *Purok Quezon, Barangay Naci, Surallah, South Cotabato on September 16 – 30, 2020.*
- B. RESOLUTION REQUIRING LGUs OF REGION 12 TO SUBMIT ADDITIONAL DATA ANALYTICS IN ITS REQUEST FOR CONCURRENCE BY THE RIATF-EID-RTF COVID 19;
- C. RESOLUTION APPROVING THE CONDUCT OF LOCAL SERBISYO CARAVANS FOR THE 21 BARANGAYS OF COTABATO PROVINCE (IN VARIOUS DATES) SUBJECT TO STRICT COMPLIANCE WITH THE HEALTH PROTOCOLS;




