RESOLUTION NO. 2020-034-B

October 15, 2020

RESOLUTION ENJOINING LGUs OF REGION XII TO REQUIRE INDUSTRIES IN ITS AORS TO SET-UP A SURVEILLANCE SYSTEM WHICH SHALL BE LINKED TO PUBLIC HEALTH SYSTEM FOR TIMELY DETECTION, ISOLATION AND SUPPRESSION OF TRANSMISSION OF COVID-19 IN THE WORKPLACE

WHEREAS, IATF Resolution No. 75-A placed the entire SOCCSKSARGEN Region under the Modified General Community (MGCQ) status effective October 1-31, 2020 without prejudice to the declaration of Localized Enhanced Community Quarantine (ECQ) in critical areas. General Santos City has also been considered an area with increased risk of transmission; whereby, the NTF and DILG were tasked to ensure the strict implementation of Zoning Containment Strategy, strict enforcement of

minimum health standards, intensified tracing and quarantine of close contacts and isolation of confirmed cases;

WHEREAS, DOH-CHD XII reported that as of October 14, 2020, the Region has a total of 1,938 confirmed cases of whom 1,312 have fully recovered, 54 deaths and 571 are currently under quarantine or confined in the referral hospitals. An average of 36 cases per day was registered;

WHEREAS, DTI and DOLE Joint Memorandum Circular No. 20-04-A entitled, "Supplemental Guidelines on Workplace Prevention and Control of COVID-19", requires the following for the remote management of cases and close contacts:

- *Employers shall ensure that the employees, regardless of work arrangements, have access to telemedicine services, either through health maintenance organization (HMO), employer-initiated telemedicine services or Barangay Health Center;*
- *Large and medium private establishments are strongly encouraged to provide their own telemedicine services, in the absence of an HMO;*

Further, the guidelines mandate proper isolation and referral of employees with symptoms and/or exposure to COVID-19 patients, viz:

- *Large and medium private establishments (i.e. with total assets of above Php 15m) and establishments with multiple tenants are mandated to designate an isolation area of one room for every 200 employees, which shall be other than the company clinic, and must be situated near the entrance/s or in nearby facility xxx; and*
- *Private establishments unable to establish an isolation area may make arrangements with a TTMF nearby or with the barangay xxx for immediate referral of employees xxx.*

WHEREAS, per DTI XII and DOLE XII report as of October 14, 2020, there are 1,137 out of 1,241 or equivalent to 91.62% R-12 establishments monitored and were found compliant to Joint Memorandum Circular No. 20-04-A;


NOW, THEREFORE, on motion of RD Aristides Concepcion Tan of DOH-CHD XII and unanimously seconded by all members; **BE IT RESOLVED**, as it is hereby resolved, to Enjoin LGUs of Region XII to Require Industries in its AOR to Set-up a Surveillance System which shall be Linked to Public Health System for Timely Detection, Isolation and Suppression of Transmission of COVID-19 in the Workplace;


