RESOLUTION NO. 2020-036-B

October 28, 2020

RESOLUTION FAVORABLY INDORSING TO NTF-COVID-19 AND IATF-EID THE REQUEST OF SURALLAH, SOUTH COTABATO FOR THE MORATORIUM OF THE ENTRY OF LSIs ON DECEMBER 24, 25, 31, 2020 AND JANUARY 1, 2021

WHEREAS, DOH-CHD XII reported that as of October 27, 2020, the Region has a total of 2,578 confirmed cases of whom 1,802 have fully recovered, 78 deaths and 697 are currently under quarantine or confined in the referral hospitals. A total of 389 cases was added in a span of seven days or an average of 56 cases per day;

WHEREAS, NTF Against COVID-19 Order No. 2020-02 entitled, "Operational Guidelines on the Management of Locally Stranded Individuals" mandates the LGUs, being at the frontline of the management and response to COVID-19, to organize the Sub-Task Group on Management of Returning Overseas Filipinos and Locally Stranded Individuals (STG on Management of ROFs and LSIs) under their Local COVID-19 Task Forces. In Region XII, the Provinces and Cities fetch their LSIs and ROFs through its *Hatid Tulong* Teams from the major entry points of Mindanao to the designated drop-off points where the component LGUs wait to pick and transport their residents going to their respective isolation units;

WHEREAS, the STG on Management of ROFs and LSIs of Municipality of Surallah, South Cotabato is tasked to facilitate the repatriation and provide assistance to ROFs and LSIs especially in transporting them from the entry/drop-off points to isolation areas 24/7 a week. As of October 27, 2020, the STG had assisted a total of 1,000 ROFs and 389 LSIs;

WHEREAS, the Local COVID-19 Task Force of Surallah during their meeting on October 16, 2020 passed Resolution No. 1 series of 2020 entitled, "Resolution Requesting for a Moratorium for Return of Locally Stranded Individuals (LSIs) on December 24, 25, 31, 2020 and January 1, 2021 to Allow the Frontliners to Celebrate the Holidays with their Family";




