RESOLUTION NO. 2020-036-C

October 28, 2020

RESOLUTION APPROVING THE REQUEST OF LGU-KIDAPAWAN CITY, PROVINCE OF COTABATO TO EXTEND THE USE OF DepEd SCHOOLS AS ADDITIONAL QUARANTINE FACILITIES UNTIL DECEMBER 2020

WHEREAS, DOH-CHD XII reported that as of October 27, 2020, the Region has a total of 2,578 confirmed cases of whom 1,802 have fully recovered, 78 deaths and 697 are currently under quarantine or confined in the referral hospitals. A total of 389 cases was added in a span of seven days or an average of 56 cases per day;

WHEREAS, the Department of Education pursuant to the instruction of President Rodrigo Roa Duterte, suspended the opening of classes among public schools from August 24, 2020 to October 5, 2020. Further, to ensure continuity of learning among students and safety of the learners and teachers, both public and private schools were prohibited to implement face-to-face classes;

WHEREAS, DepEd Office Memoranda Nos. 2, 3, 4 and 5 series of 2020, allow the LGUs to use the public schools as quarantine or isolation areas for COVID-19 provided that the following requirements are met:

- *Documents to prove that all other facilities were assessed but were found inadequate;*

- *Assessment result from local officials stating that the identified school is suitable for intended purpose (LHO for health related, LSWDO for welfare related); and*
- *DILG certification which attest that all activities to be conducted in schools are within the parameters set by the National Government;*

WHEREAS, LGU Kidapawan City has expressed its intent to extend the use of 42 DepEd schools as isolation/quarantine facilities capable of housing 238 individuals. This shall serve as additional facilities to the existing 43 identified public buildings capable of catering 297 individuals. Schools are primarily used as isolation/quarantine facilities of close contacts of COVID-19 patients and LSIs from high risk areas;

WHEREAS, in a letter dated October 1, 2020, DepEd Undersecretary for Field Operations, Atty. Revsee A. Escobedo has instructed DepEd XII that all requests of LGUs for extension on the use of public schools as quarantine facilities shall be evaluated and decided upon by RIATF-EID XII. In cases where requests will be denied, concerned LGU may appeal the decision to IATF-EID;

WHEREAS, the Joint Task Force during its 23rd meeting has evaluated the request of LGU Kidapawan City. The Body decided to approve the request but it shall ensure the strict observance of quarantine protocols among close contacts and LSIs, thereby containing the spread of the virus in the said LGU. It is also expected from the LGU that all classrooms that are utilized as isolation facilities be cleaned properly and space be provided for teachers who are physically reporting;


NOW, THEREFORE, on motion of RD Teresita Socorro Ramos of NEDA XII and seconded by RD Macario Gonzaga of LTO XII; **BE IT RESOLVED**, as it is hereby resolved, to Approve the Request of LGU Kidapawan City, Province of Cotabato to Extend the Use of DepEd Schools as Additional Quarantine Facilities until December, 2020;


