RESOLUTION NO. 004-2020

RESOLUTION EXPRESSING GRATITUDE TO PBGEN ALFRED S. CORPUS, FORMER REGIONAL DIRECTOR OF PNP-PRO 12 FOR THE INVALUABLE SERVICES RENDERED AS MEMBER OF THE RIATF-EID XII

WHEREAS, On April 1, 2020, the Regional Inter-Agency Task Force on Emerging Infectious Disease (RIATG-EID) XII was established as a Policy Making body of the Region in Managing Emerging Infectious Disease particularly on COVID-19.

Subsequently, on May 13, 2020, the RIATG-EID was restructured to RIATF-EID XII in accordance with IATF Resolution No. 34 s. 2020 with PNP-PRO 12 headed by PBGen Alfred S Corpus as one of the members;

WHEREAS, during the pandemic situation in the Region, the PNP-PRO 12 played vital roles with the able leadership of RD Corpus in ensuring the unhampered movement of APORs and Frontliners and entry and exit of cargoes within and outside of the region; safe and orderly implementation of Special Amelioration Program (SAP) of DSWD; smooth implementation of the repatriation of the returning Overseas Filipinos (ROFs) and Locally Stranded Individuals (LSIs); Curfew Hour; Social Distancing Measures of the LGUs; and Distribution of Food Packs, among others;

WHEREAS, last May 21, 2020, a Turn-Over Ceremony was held signaling a change in the command and leadership of PNP-PRO 12. PBGen Alfred S Corpus served the people of Region 12 for a period of 8 months & 12 days (September 12, 2019-May 20, 2020) before being succeeded by PBGen Michael Anthony Dubria as RD of PNP PRO 12;

WHEREAS, upon thorough deliberation, the RIATF-EID XII member agencies deemed it necessary to recognize and convey gratitude for the contributions and



untiring services of the PNP-PRO 12 during the pandemic situation in the region under the leadership of the PBGen Alfred S Corpus;
