RESOLUTION NO. 2020-032

September 30, 2020

**POLICY GUIDELINES AND RECOMMENDATIONS RELATIVE TO THE MANAGEMENT OF
CORONAVIRUS DISEASE (COVID-19) SITUATION IN REGION 12**



WHEREAS, Per OMNIBUS GUIDELINES ON THE IMPLEMENTATION OF COMMUNITY QUARANTINE IN THE PHILIPPINES *with Amendments as of July 16, 2020*, the IATF approved the Implementation of the Modified Enhanced Community Quarantine (MECQ) including the zoning concept, corresponding qualification, and its phased response or intervention;

As of September 2, 2020, Region 12 being placed under Modified General Community Quarantine (MGCQ) status, have to strictly observe the following, to wit:

- **Minimum public health standards** shall be complied with at all times for the duration of the MGCQ;
- **The movement of all persons shall be limited to accessing essential goods and services, for work in the offices or industries permitted to operate hereunder**, and for other activities permitted under this Section. *(As amended by Paragraph A(4)(a) of IATF Resolution No. 43, June 03, 2020);*
- **Mass gatherings such as but not limited to, movie screenings, concerts, sporting events, and other entertainment activities, religious services, and work conferences shall be allowed provided that participants shall be limited to fifty percent (50%) of the seating or venue capacity.** *(As amended by Paragraph A(4)(d) of IATF Resolution No. 43, June 03, 2020)*

WHEREAS, on September 16, 2020, the President issued Proclamation No. 1021 (s. 2020) extending the period of State of Calamity throughout the Philippines due to Coronavirus Disease 2019 declared under Proclamation No. 929 (s. 2020)

WHEREAS, IATF Resolution No. 75-A dated September 28, 2020 pursuant to the appeals of the LGUs and recommendations of the IATF Screening and Validation Committee approved the following:

- Effective October , 2020, the risk-level classifications of Provinces, HUCs, ICCs shall be as follows:
 - the following provinces, HUCs and ICCs shall be placed under Modified General Community Quarantine until October 1, 2020, without prejudice to the declaration of localized Enhanced Community Quarantine as follows:

For Mindanao:

Region XII: North Cotabato; South Cotabato; Sarangani; Sultan Kudarat; General Santos City and Cotabato City
- All provinces, HUCs and ICCs shall continue to observe the strict implementation of the following:
 - **Localized community quarantine and availability of identified quarantine facilities in priority or critical areas with community**

transmission, including private and public establishments, with concurrence of the Regional IATF;

- *Immediate facility-based quarantine or isolation of all returning citizens, suspect and probable cases;*
- *Scaling up of local health system facility, especially for community isolation and critical care, including dedicated mechanical ventilators, and ICU, isolation, and ward beds for COVID-19 cases;*

WHEREAS, as of September 29, 2020, DOH XII COVID-19 Tracker revealed that the Region has a total of **1,201 confirmed cases**. There is an increase of **two hundred three (203) COVID-19 cases** for a span of 6 days, which is equivalent to an average of **33.83 cases per day**.

WHEREAS, during the meeting, the LCEs conveyed their observations that there are residents and a number of establishments failed to comply and or disregard the 50% requirement on Mass Gatherings as specified under Section 5 Item 5 of IATF Omnibus Guidelines dated July 3, 2020;

WHEREAS, with the increasing COVID-19 cases in the region, concerns regarding the capacity of health care systems of some LGUs and the inadequacy of temporary treatment monitoring facilities (TTMFs) were raised for consideration; hence, the Body concurred and or approved the requests of five (5) LGUs for "Localized Lockdown", namely:

1. Municipality of Kalamansig
 - *Purok Orchids, Purok Malipayon and Purok Santan, Barangay Cadiz;*
2. Tacurong City, Sultan Kudarat
 - *Purok Saranay, Barangay San Pablo;*
 - *Purok 2, Barangay, Poblacion;*
 - *National Highway, Purok Malipayon, Barangay New Carmen;*
 - *National Highway corner Brgy. San Pablo Road going to Purok Saranay; and*
 - *Barangay Road going to Tacurong Integrated Terminal, Brgy New Isabela*
3. Surallah, South Cotabato
 - *Barangay Libertad, Surallah*
4. Pigcawayan, Province of Cotabato
 - *Zone 2, Zone 3, Zone 4 & Zone 5, Barangay Presbitero;*
5. Antipas, Province of Cotabato
 - *Purok 5B, Barangay Poblacion*
6. City of Koronadal, South Cotabato
 - *Entire Barangay Sta. Cruz;*
 - *Puroks Malipayon and River West, Barangay Sto. Niño*

WHEREAS, during the Joint RIATF-EID XII and RTF COVID-19 Meeting, the Body discussed, strategized and resolved emerging local issues and determined appropriate and future actions to avoid the further spreading of the virus given the foregoing premises;

NOW, THEREFORE, BE IT RESOLVED, as it is hereby resolved, that the Joint RIATF-EID XII- RTF-COVID-19 approved the following Resolutions:

A. RESOLUTION CONCURRING THE REQUEST FOR LOCALIZED LOCKDOWN OF VARIOUS LGUs OF REGION 12 W/ SPECIFIC DATES SUBJECT TO THE RECOMMENDATIONS OF THE SCREENING AND VALIDATION TEAM

- ***Kalamansig, Province of Sultan Kudarat on September 22 - October 6, 2020***
 - *Purok Orchids, Purok Malipayon and Purok Santan, Barangay Cadiz, Kalamansig, Sultan Kudarat;*

- ***Tacurong City, Province of Sultan Kudarat***
 - September 23-October 8, 2020**
 - *Purok Saranay, San Pablo, Tacurong City*
 - *Purok 2, Poblacion, Tacurong City*
 - September 26 - October 2, 2020**
 - *National Highway, Purok Malipayon, New Carmen, Tacurong City*
 - *National Highway corner Brgy. San Pablo Road going to Purok Saranay;*
 - *Barangay Road going to Tacurong Integrated Terminal, Brgy New Isabela, Tacurong City*


- ***Surallah, Province of South Cotabato***
 - September 20, 2020 – October 4, 2020**
 - *Libertad, Surallah, South Cotabato*


