**RESOLUTION REQUESTING DOTr TO ENSURE STRICT OBSERVANCE OF HEALTH PROTOCOLS
IN THE LAND, AIR, AND SEA TRANSPORTATIONS**

WHEREAS, IATF-EID Resolution No. 46-A adopted the recommendations of the IATF Screening and Validation Committee thereby extending the Modified General Community Quarantine (MGCQ) status of Region XII's provinces and HUC General Santos City, and BARMM's ICC- Cotabato City until June 30, 2020;

WHEREAS, Section 5 of the Omnibus Guidelines on the Implementation of Community Quarantine in the Philippines with Amendments as of June 3, 2020 provides for the following:

- **The movement of all persons in areas placed under MGCQ shall be limited to accessing essential goods and services,** for work in the offices or industries permitted to operate hereunder, and for other activities permitted under this Section. (As amended by Paragraph A(4)(a) of IATF Resolution No. 43, June 03, 2020);
- The road, rail, maritime, and aviation sectors of public transportation shall be allowed to operate at the capacity **in accordance with guidelines issued by the DOTr.** Provided, that in all public transports, **a strict one (1) meter distance between passengers** shall be observed and appropriate engineering controls shall be in place; and

all times; Provided that all activities and movements allowed under other Sections of the Guidelines for the foregoing persons shall continue to be permitted under MGCQ. (As amended by Paragraph A(4)(b) of IATF Resolution No. 43, June 03, 2020);

- (7) The road, rail, maritime, and aviation sectors of public transportation shall be **allowed to operate at the capacity in accordance with guidelines issued by the DOTr**. Provided, that in all public transports, a strict one (1) meter distance between passengers shall be observed and appropriate engineering controls shall be in place; and
- (8) Private transportation shall be allowed subject to the guidelines provided by DOTr.

Section 7. GUIDELINES FOR INTERZONAL AND INTRAZONAL MOVEMENT.

- (1) LGUs and local health units (LHUs) are hereby enjoined not to issue orders contrary to or inconsistent with said directive, such as, but not limited to, requiring asymptomatic drivers and crew of cargo or service delivery vehicles to undergo mandatory fourteen (14)-day home quarantine. Provided, further, that strict social distancing measures must be observed, which may include, if necessary, **the putting up of additional safe and humane seats or space in the vehicles**.
- (2) The movement as such of the following persons within and across areas placed under any form of community quarantine shall be permitted: (1) health and emergency frontline services personnel, (2) government officials and government frontline personnel, (3) duly-authorized humanitarian assistance actors (HAAs), (4) persons traveling for medical or humanitarian reasons, (5) persons going to the airport for travel abroad, (6) returning or repatriated OFWs and other Overseas Filipinos (OFs) returning to their places of residence, (7) other persons transported through the efforts of the national government upon observance of the necessary quarantine protocols and with the concurrence of the receiving LGUs, and (8) anyone crossing zones for work permitted in the zone of destination, and going back home. Authorized shuttle services shall be allowed to travel within and across areas placed under any form of community quarantine, with priority given to persons rendering health and emergency frontline services;
- (3) The interzonal movement of persons between areas placed under GCQ and MGCQ for any purpose **other than leisure shall be permitted**; and
- (4) Movement to and from an area placed under GCQ to an area where no community quarantine is in place shall be permitted, except for the sole

- Private transportation shall be allowed subject to the guidelines provided by DOTr.

WHEREAS, during the Meeting of the Governors and City Mayors of Region XII, DILG XII and OCD XII held last June 15, 2020, it was raised that observance of health protocols during land, air and sea travels within and across Region XII were not strictly observed by passengers and/or operators. The most common issue being observed is the absence of physical distancing and mandatory wearing of mask by some passengers waiting inside and outside of the terminal, airports and ports or even inside the PUVs.


WHEREAS, during the Joint RIATF-EID XII and RTF COVID-19 Meeting, the Body discussed the said issue and came up with a recommendation to request DOTr to ensure strict observance of Health Protocols in the land, air and sea transportations;


NOW, THEREFORE, on motion of RD MACARIO GONZAGA of LTO XII and duly seconded by RD TERESITA SOCORRO C. RAMOS of NEDA XII; **BE IT RESOLVED, AS IT IS HEREBY RESOLVED**, to Request DOTr to Ensure Strict Observance of Health Protocols in the Land, Air, and Sea Transportations


