RESOLUTION NO. 2020-017-D

June 17, 2020

RESOLUTION RESTRICTING NON-ESSENTIAL TRAVEL AT GLAN AND MALUNGON OF SARANGANI PROVINCE BORDERS

WHEREAS, IATF-EID Resolution No. 46-A adopted the recommendations of the IATF Screening and Validation Committed thereby extending the Modified General Community Quarantine (MGCQ) status of Region XII's provinces and HUC General Santos City, and BARMM's ICC- Cotabato City until June 30, 2020;

WHEREAS, the IATF-EID issued Omnibus Guidelines on the Implementation of Community Quarantine in the Philippines with Amendments as of June 3, 2020. Sections 5 and 7 of the Guidelines provide for the following:

SECTION 5. GUIDELINES FOR AREAS PLACED UNDER MODIFIED GENERAL COMMUNITY QUARANTINE (MGCQ). Areas placed under MGCQ shall observe the following protocols:

The movement of all persons in areas placed under MGCQ shall be limited to accessing essential goods and services, for work in the offices or industries permitted to operate hereunder, and for other activities permitted under this Section. (As amended by Paragraph A(4)(a) of IATF Resolution No. 43, June 03, 2020).

SECTION 7. GUIDELINES FOR INTERZONAL AND INTRAZONAL MOVEMENT.

*The interzonal movement of persons between areas placed under GCQ and MGCQ for any purpose **other than leisure shall be permitted.***

WHEREAS, RIATF-EID XII and RTF COVID-19 Resolution No. 2020-016-B dated June 10, 2020 approves and extends Region 12's Regional Border Lockdown until June 30, 2020;


WHEREAS, given the increasing number of positive cases in the region, at least 13 additional COVID-19 cases in the span of 16 days (June 1, 2020 – June 16, 2020), the RIATF-EID and RTF COVID 19 finds it necessary to support the recommendation of Sarangani COVID-19 Task Force to restrict non-essential travel to Glan and Malungon of Sarangani Province Borders;


NOW, THEREFORE, on motion of RD Macario Gonzaga of LTO XII and duly seconded by RD Teresita Socorro Ramos of NEDA XII; **BE IT RESOLVED, AS IT IS HEREBY RESOLVED,** to Restrict Non-Essential Travel at Glan and Malungon of Sarangani Province Borders;

RESOLVED FURTHER, that a copy of this Resolution be forwarded to the Provincial Governors, City and Municipals Mayors of Region XII for their consideration and appropriate action. The same copy to be furnished to the members of the RIATF-EID XII & RTF COVID-19 for their information.


