## RESOLUTION NO. 2021-25

RESOLUTION REQUESTING THE CIVIL SERVICE COMMISSION (CSC) XII TO ENCOURAGE ALL CIVIL SERVICE EXAMINEES TO BE VACCINATED PRIOR TO SCHEDULED EXAM, AS PART OF REGION XII'S STRATEGY IN RAMPING UP THE VACCINATION PROGRAM

WHEREAS.

as the country ramps up the implementation of the COVID-19 Vaccination nationwide, the national government have introduced various vaccination strategies to expedite vaccination activities toward achieving herd immunity;

WHEREAS, in Region XII, one of the approaches identified to increase the COVID-19 vaccination coverage is to encourage civil service examinees to get vaccinated prior to the examination date to mitigate the possibility of this mass participation event of becoming a COVID-19 super spreader event;

WHEREAS, the Body recognizes the need to ramp up the vaccination implementation in the Region, thereby recommending possible ways while preventing COVID-19 virus;

vaccination is one way of preventing the spread of COVID-19, and protect WHEREAS, examinees from COVID-19 virus transmission;

NOW THEREFORE, on motion of RD Servillano Santiago Lorenzo III of DOJ XII and seconded by RD Aristedes Tan of DOH-CHD XII; BE IT RESOLVED, as it is hereby RESOLVED, to request the Civil Service Commission (CSC) XII to encourage all Civil Service Examinees to be vaccinated prior to the scheduled exam, as part of Region XII's strategy in ramping up the vaccination program.
