**RESOLUTION REITERATING RIATF EID XII-RTF COVID-19 XII RESOLUTION NO. 2020-020A
REQUESTING CAAP NATIONAL OFFICE TO REQUIRE LSIs OF REGION XII TO
PRESENT THEIR NEGATIVE RT-PCR TEST WITHIN
48 HOURS UPON BOARDING**

WHEREAS, RIATF-EID XII and RTF-COVID-19 XII on its weekly meeting on July 8, 2020 passed Resolution No. 2020-20-A entitled Resolution Requiring Certificate of Confirmation from the Receiving LGUs and Negative RT-PCR Test Result Among Inbound LSIs of Region 12. The said protocol is aimed to ensure that all inbound LSIs are bonafide residents of the Region, healthy and not capable of infecting the communities with COVID-19;

WHEREAS, DOH-CHD XII COVID-19 Tracker revealed that the Region, as of July 21, 2020, has one hundred seventy nine (179) confirmed patients, three of whom died, sixty eight (68) have fully recovered, and one hundred seven (107) are still on a

quarantine. Among the active cases, ninety seven (97) or 90.65.% are ROFs and LSIs, nine have no travel history and one is still uncategorized;

WHEREAS, 85.51% or fifty nine (59) of the sixty nine (69) new recorded cases as of July 15-21, 2020 are Locally Stranded Individuals. The continued spike of cases among LSIs coming in the Region implies that the protocols set in RIATF EID XII and RTF-COVID-19 XII Resolution No. 2020-20A are not strictly implemented;

WHEREAS, during the Joint RIATF-EID XII and RTF COVID-19 Meeting, the Body discussed, strategized, and resolved emerging local issues and determined appropriate or future actions to avoid the further spreading of the virus;


NOW, THEREFORE, on motion of RD Teresita Socorro Ramos of NEDA XII and duly seconded by RD Macario D. Gonzaga of LTO XII; **BE IT RESOLVED**, as it is hereby resolved, to Reiterate RIATF-EID XII-RTF COVID-19 XII Resolution No. 2020-020A to Request CAAP National Office to Require LSIs of Region XII to Present their Negative RT-PCR Test within 48 Hours Upon Boarding;

RESOLVED FURTHER, that a copy of this Resolution be forwarded to the National IATF-EID, NTF COVID-19, Provincial Governors, City and Municipal Mayors of Region XII, for their consideration and appropriate action. The same copy to be furnished to the members of the RIATF-EID XII & RTF COVID-19 for their information and/or appropriate action.


