**RESOLUTION NO. 2021-07B**

April 7, 2021

**RESOLUTION REQUESTING IATF-EID TO TEMPORARILY SUSPEND THE INBOUND  
COMMERCIAL FLIGHTS OF GENSAN INTERNATIONAL AIRPORT WHILE  
NCR AND ITS NEIGHBORING LGUs ARE ON ECQ UNTIL  
TWO WEEKS AFTER THE LIFTING THEREOF**

**WHEREAS**, the IATF Resolution No. 107-A has classified the entire Region XII under Modified General Community Quarantine (MGCQ) from April 1 to April 30, 2021. Further, the Omnibus Guidelines on the Implementation of Community Quarantine in the Philippines provided for the minimum protocols to be observed in areas under the MGCQ status requiring the strict implementation of the following: minimum public health standards shall be complied with at all times xxx; and the movement of all persons shall be limited to accessing essential goods and services, for work in the offices or industries permitted to operate xxx;

**WHEREAS**, President Rodrigo Roa Duterte on April 3, 2021 has approved the recommendation of the IATF-EID to extend the Enhanced Community Quarantine (ECQ) classification of the National Capital Region (NCR), Bulacan, Cavite, Laguna and Rizal for one week starting April 5 until April 11, 2021;

**WHEREAS**, DOH-CHD XII reported that as of April 6, 2021, the Region has a total of 6,276 confirmed cases of whom 5,768 have fully recovered, 227 deaths and 279 are currently under quarantine or confined in the referral hospitals. A total of 185 cases was recorded in a span of seven days or an average of 27 cases per day;

**WHEREAS**, DOH-CHD XII also recorded that among the active cases, four individuals are returning residents from various areas of the country;

**WHEREAS**, IATF-EID Resolution No. 101 dated February 26, 2021 provides that testing shall not be mandatory for travelers except if the LGU of destination will require testing as a requirement prior to travel which shall be limited to RT-PCR, and no traveler shall be required to undergo quarantine unless they exhibit symptoms upon arrival at the LGU of destination;

**WHEREAS**, the GenSan International Airport serves as the entry point of returning residents and ROFs alike to Region XII and other adjacent Regions. For the month of March, the airport has catered a total of 5,292 returning residents or an average of 171 individuals per day;


**WHEREAS**, during the meeting of the Joint RIATF-EID XII and RTF-COVID 19, members of the Task Force have observed that the relax protocols imposed among inbound passengers is a serious threat to possible spread of the virus at the household level;


**NOW, THEREFORE**, on motion of RD Macario D. Gonzaga of LTO XII and seconded by RD Teresita Socorro C. Ramos of NEDA XII; **BE IT RESOLVED**, as it is hereby resolved, to Request IATF-EID to Temporarily Suspend the Inbound Commercial Flights of GenSan International Airport while NCR and its Neighboring LGUs are on ECQ until Two Weeks After the Lifting Thereof;

**RESOLVED FURTHER**, that a copy of this Resolution be forwarded to the IATF-EID and NTF COVID-19 for their information and support. The same copy shall be furnished to Civil Aviation Authority of the Philippines (CAAP) and RIATF-EID XII and RTF COVID-19 XII members for their information.
