**RESOLUTION REQUESTING CIVIL AVIATION AUTHORITY OF THE PHILIPPINES-GENSAN
AND PHILIPPINE PORTS AUTHORITY-SOCSARGEN TO CONDUCT BORDER
SCANNING OF THE S-PASS FOR TRAVELERS
COMING TO REGION 12**

WHEREAS, IATF-MEID has released Resolution No. 136-F on September 6, 2021 which classified the entire Region under General Community Quarantine (GCQ) until September 30, 2021;

WHEREAS, DOH-CHD XII reported that as of September 7, 2021, the Region has a total of 39,918 confirmed cases of whom 33,466 have fully recovered, 1,288 deaths and 5,157 are currently under quarantine or confined in the referral hospitals. An average of 397 cases was recorded in a span of fourteen days;

WHEREAS, DOST has developed the Safe, Swift and Smart Passage or S-PaSS as an innovative travel management system for local travelers who are returning to or visiting different localities for vacation or for official business. The travel management system allows local travelers to access information on travel restrictions imposed by different LGUs due to COVID-19 pandemic;

WHEREAS, IATF-MEID Resolution No. 101 dated February 26, 2021 required the institutionalization of DOST S-PaSS by the LGUs as the one-stop-shop application/communication for travelers;

WHEREAS, the Joint RIATF-EID XII and RTF-COVID-19 XII during its regular meeting on August 11, 2021 had adopted Resolution No. 2021-16A entitled, "Resolution Reiterating the Adoption and Use of S-PaSS for All Travelers by LGUs of Region 12 that are not yet Implementing it";



WHEREAS, the Body agreed that with the surge of COVID-19 cases and the entry of Delta variant in the Region, there is a need for all LGUs to enforce the said IATF-EID directive;

WHEREAS, the Body acknowledged that the strict scanning of S-PaSS in the entry points will ensure that local travelers are properly documented and coordinated to the host LGUs. This will improve the profiling and monitoring of local travelers, strengthen the enforcement of local travel restrictions and guidelines, and eventually prevent the spread of COVID-19 in the Region;

NOW, THEREFORE, on motion of RD Sammy Manlawan of DOST XII, and seconded by RD Aristides Concepcion Tan of DOH XII; **BE IT RESOLVED**, as it is hereby resolved, to Request Civil Aviation Authority of the Philippines-GenSan and Philippine Ports Authority-Socsargen to Conduct Border Scanning of the S-PaSS for Travelers Coming to Region 12;

RESOLVED FURTHER, that a copy of this Resolution be forwarded to all members of the RIATF-EIDX II and RTF-COVID-19 XII for their information. The same copy shall be furnished to all Local Government Units of Region 12, Manager Joel G. Gavina of CAAP-Gensan and Manager Cesar M. Dataya of PPA-Socsargen for their information and appropriate action.


