**RESOLUTION APPROVING THE JOINT REGIONAL MEMORANDUM CIRCULAR 2021-01
PERTAINING TO THE INTERIM GUIDELINES IN THE SAFETY SEAL
CERTIFICATION AND INSPECTION OF REGIONAL OFFICES OF
NATIONAL LINE AGENCIES IN REGION 12**

WHEREAS, IATF-MEID has released Resolution No. 87 dated December 3, 2020 adopting the implementation of the Safety Seal Certification Program which requires all establishments (i.e. government offices, private companies, hotels, and business establishments) and public transportation units to adopt the Safety Seal;

WHEREAS, DOLE, DOH, DILG, DOT and DTI issued Joint Memorandum Circular No. 21-01 which sets the guidelines of the Safety Seal Certification Program. It delineates the coverage of the agencies involved as issuing authorities of the Safety Seal. However, it may be noted that the directive has not specified the agency or body that will carry out the inspection/validation and subsequently issue Safety Seal Certifications to NGA offices' compliance to Safety Seal requirements;

WHEREAS, the Body during its regular meeting on August 25, 2021 adopted Resolution No. 2021-17C entitled, "Resolution Organizing the Regional Inter-Agency Committee Composed of DILG, DTI, DOT and DOLE as Issuing Authority of Safety Seal for National Government Agencies (NGAs) of Region 12". The Committee had their first meeting on September 3, 2021 and DILG was elected as the Chairperson of the Committee. A draft Joint Regional Memorandum Circular 2021 specifying the Interim Guidelines in the Safety Seal Certification and Inspection of Regional Offices of National Line Agencies of Region 12 was also formulated by the Committee Member Agencies subject to approval of RIATF-EID XII and RTF-COVID19 XII;

WHEREAS, the Body agreed that the implementation and enforcement of the Safety Seal Program by the Regional Line Agencies will protect the well-being of its personnel along with their family members;


NOW, THEREFORE, on motion of RD Aristides Concepcion Tan of DOH-CHD XII, and unanimously seconded by RD Macario D. Gonzaga of LTO XII, ARD Jerome B. Barranco of OCD XII, and ARD Flora Gabunales of DTI XII; **BE IT RESOLVED**, as it is hereby resolved, to Approve Joint Regional Memorandum 2021-01 Pertaining to the Interim Guidelines in the Safety Seal Certification and Inspection of Regional Offices of National Line Agencies in Region 12;

RESOLVED FURTHER, that a copy of this Resolution be forwarded to the IATF-EID, NTF COVID-19, and members of RIATF-EID XII and RTF-COVID-19 XII for their information and support. The same copy shall be furnished to all Regional Line Agencies for their information, reference and appropriate action.


