RESOLUTION NO. 2021-20A

October 6, 2021

RESOLUTION REQUESTING THE LOCAL GOVERNMENT UNITS (LGUs) OF REGION 12 TO DESIGNATE PERMANENT AND ALTERNATE FOCAL PERSONS FOR ONE HOSPITAL COMMAND CENTER (OHCC) COORDINATION IN THEIR RESPECTIVE LOCAL COMMAND CENTERS

WHEREAS, the IATF Resolution No. 141-A has classified the entire Region XII under General Community Quarantine (GCQ) with heightened restrictions until October 31, 2021. Further, the Omnibus Guidelines on the Implementation of Community Quarantine

in the Philippines dated September 23, 2021, *as updated*, provided for the minimum protocols to be observed in areas under the GCQ status requiring the strict implementation of the following: minimum public health standards shall be complied with at all times xxx; and the movement of all persons shall be limited to accessing goods and services from permitted establishments, for work in such establishments, or for such other activities xxx;

WHEREAS, DOH-CHD XII reported that as of October 5, 2021, the Region has 52,059 total cumulative confirmed cases with 4,327 (8%) active cases, 45,997 (88%) have fully recovered, 1,726 (3.32%) deaths, and 11,335 are currently under quarantine or confined in the referral hospitals. A total of 4,318 cases was recorded in a span of two weeks from September 22 to October 5, 2021;

WHEREAS, DOH-CHD XII, on October 28, 2020, released Regional Order No. 0020 s. 2020 entitled, "Regional Guidelines on the Establishment and Institutionalization of the One Hospital Command System in SOCCSKSARGEN Region." The same guidelines require the Provinces to establish One Hospital Command System Operation Center preferably in a Level 1 or Level 2 government hospital to serve as the nerve center of OHCS;

WHEREAS, On November 11, 2020, the Body passed Resolution No. 2020-037-C, urging all the Provincial LGUs to lead in the organization of the One Hospital Command System. It aims to ensure a comprehensive and coordinated response to the COVID-19 pandemic by establishing an effective and efficient health facility referral system;

WHEREAS, updates on the status of Regional One Hospital Command Center (OHCC) presented by DOH-CHD XII during the Joint RIATF-EID XII – RTF on COVID XII Meeting on October 6, 2021; reports revealed that as of October 5, 2021, only 48 out of 118 health facilities in the entire Region XII submit report resulting to only 40.65% OHCC Module Compliance;

WHEREAS, DOH-CHD XII also conducted series of OHCC-related orientations from November 19, 2020, to September 10, 2021, to firm up the implementation of OHCC among hospitals in Region XII to include the orientation of DCC-OHCC Module Dashboard for convenient daily reporting;

WHEREAS, the region has encountered some issues resulting in the low compliance status of OHCC implementation, which are as follows: (1) no permanent focal person identified by hospitals, (2) different implementation of policies per LGU, and (3) dashboards not updated in real-time;

WHEREAS to address these prevailing issues in One Hospital Command Center operation, the Body enjoins all LGUs of Region 12 to designate permanent and alternate focal persons for OHCC Coordination in their respective Local Command Centers to include the required daily reporting;

NOW THEREFORE, on motion of RD Aristedes Conception Tan, MD of DOH XII and seconded by RD Minda Morante of OCD XII; **BE IT RESOLVED**, as it is hereby **RESOLVED**, to request the local government units of Region XII to designate permanent and alternate focal

persons for One Hospital Command Center (OHCC) Coordination in their respective local command centers;

RESOLVED FURTHER, that a copy of this Resolution be forwarded to the IATF-EID, NTF COVID-19 for their information, and members of RIATF-EID XII and RTF-COVID-19 XII for their gratitude and support. The same copy shall also be furnished to all Provincial Governors for their information and appropriate action.
