**RESOLUTION NO. 2021-21**

October 20, 2021

**RESOLUTION ENJOINING ALL PUNONG BARANGAYS OF REGION XII TO TAKE THE LEAD IN INFLUENCING THEIR RESPECTIVE CONSTITUENTS TO GET VACCINATED**

**WHEREAS**, the IATF-MEID issued Resolution No. 95 dated January 21, 2021 approving the Philippine National Deployment and Vaccination Plan for COVID-19 Vaccines (NDVP). The plan adopts the whole-of-government and whole-of-society approach. As such, government agencies are enjoined to coordinate with the CSOs, private groups, media men and other stakeholders for the smooth implementation of the program;

**WHEREAS**, DILG issued Memorandum Circular 2021-07 dated January 18, 2021 enjoining the LGUs to prepare their vaccination plans. Specifically, the LGUs are mandated to prepare their risk communication plan, master list of priority of eligible vaccine population, list of designated vaccine centers, cold chain storages and other logistical requirements; master list of human resources and personnel for the program; and reorganized EOC dedicated for vaccine concerns, among others;

**WHEREAS**, During the Joint RIATF-EID XII and RTF on COVID-19 Meeting held on October 20, 2021, DOH-CHD XII reported that Region XII is No. 6 among regions with the highest number of "unvaccinated" individuals. Currently, the A2 Group is on the

line in the vaccination priority, but the region has not yet reached its 50% target. DOH-CHD XII confirmed in the meeting that vaccination would start among 12- to 17-year-olds once adequate coverage of A2 Priority Group has been achieved;

**WHEREAS**, the LGUs, being at the frontline of COVID-19 disaster response, are expected to fast track the implementation of vaccination program to ensure community herd immunity against the virus;

**WHEREAS**, pursuant to the Philippine National COVID-19 Vaccination Deployment Plan maximizing the speed and impact of the National COVID-19 Vaccination Program underscores the role of local vaccination centers (LVOC) to coordinate and collaborate with barangays;

**WHEREAS**, Punong Barangays should take the lead from the preparation of vaccination preparedness plans up to deployment of BHERTS and the operational aspects of vaccination rollout at the barangay level;

**WHEREAS**, the National Vaccination Plan targets the Punong Barangays, BHWs, BHERTs and other local officials are oriented and/or capacitated on the COVID-19 vaccination campaign; Awareness -raising activities for eligible population (group orientation; announcements; barangay assemblies; townhall meetings; online Q&A sessions) are among the strategies to speed up the vaccination rollout;


**WHEREAS** to address these prevailing issues in the speedy vaccination roll-out in all areas, the Body enjoins all Punong Barangays of Region XII to take the lead in influencing their respective constituents to get vaccinated;


**NOW THEREFORE**, on motion of RD Flora Gabunales of DTI XII and seconded by RD Rocafort, of DepEd XII; **BE IT RESOLVED**, as it is hereby **RESOLVED**, to enjoin all Punong Barangays of Region XII to take the lead in influencing their respective constituents to get vaccinated;

**RESOLVED FURTHER**, that a copy of this Resolution be forwarded to the IATF-EID, NTF COVID-19 for their information, and members of RIATF-EID XII and RTF-COVID-19 XII for their gratitude and support. The same copy shall also be furnished to all Local Chief Executives and Punong Barangays for their information and appropriate action.


