RESOLUTION NO. 2021-23

November 3, 2021

RESOLUTION EXTENDING THE DEADLINE OF THE SUBMISSION OF SAFETY SEAL APPLICATION FOR REGIONAL LINE AGENCIES UNTIL NOVEMBER 30, 2021

WHEREAS, IATF-MEID has released Resolution No. 87 dated December 3, 2020 adopting the implementation of the Safety Seal Certification Program which requires all establishments (i.e. government offices, private companies, hotels, and business establishments) and public transportation units to adopt the Safety Seal;

WHEREAS, DOLE, DOH, DILG, DOT and DTI issued Joint Memorandum Circular No. 21-01 which sets the guidelines of the Safety Seal Certification Program. It delineates the coverage of the agencies involved as issuing authorities of the Safety Seal;

WHEREAS, DILG issued Memorandum Circular No. 53 dated May 12, 2021 which provides for the implementing guidelines of the Safety Seal Certification Program for the Department and the LGUs as Issuing Authorities; The RIATF-EID XII and RTF on COVID-19 XII in adherence to DILG MC No. 53, believes that with the gradual resumption of full workload operation among many NGAs, the minimum health protocols in the workplace should be strictly observed at all times to prevent COVID-19 transmission in the offices and household members of the APORs;

WHEREAS, there are only six (6) Regional Offices that applied for Safety Seal in the Inter-Agency Certification and Inspection Team as of September 30, 2021. RIATF-EID XII and RTF on COVID-19 XII created the Regional Inter-Agency Committee Composed of DILG, DTI, DOT, and DOLE as Issuing Authority of Safety Seal for NGAs of Region 12. Accordingly, the team recommends to extend the deadline to give the Regional Offices more time to comply with the requirements of the Joint Regional Memorandum Circular;

WHEREAS the Body recognizes the intensive preparation of Regional Line Agencies in complying with the Safety Seal Certification Checklists such as office policies, IT-based solutions, documentation of health protocols, among others.

NOW THEREFORE, on motion of RD Akmad Usman of DBM XII and seconded by RD Aristedes Tan of DOH-CHD XII; **BE IT RESOLVED,** as it is hereby **RESOLVED,** to extend the deadline of the submission of Safety Seal application of Regional Line Agencies until November 30, 2021;

RESOLVED FURTHER, that a copy of this Resolution be forwarded to the IATF-EID, NTF COVID-19, and members of RIATF-EID XII and RTF-COVID-19 XII for their information. The same copy shall also be furnished to all Regional Line Agencies of Region XII for their information and appropriate action.


