**RESOLUTION COMMENDING THE TEAMS OF THE IMMERSION PROGRAM OF THE RIATF-  
EID XII AND RTF XII ON COVID-19 DURING THE THREE-DAY NATIONAL COVID-19  
VACCINATION DAYS ON NOVEMBER 29, 30 AND DECEMBER 1, 2021**

**WHEREAS,** the National COVID-19 Vaccination Days dubbed as “Bayanihan, Bakanuhan” on November 29, 30 and December 1, 2021 maximizes the “bayanihan” concept

where communities unite, work, and cooperate together to achieve the goal of herd immunity in the entire country, as well as mobilizing all stakeholders, people and logistics to facilitate the COVID-19 vaccination to at least 9 million individuals in three (3) days;

**WHEREAS,** with the strong collaboration and support of local government units, National Government Agencies, and stakeholders, Region XII have stepped up beyond the guidance of the national government, thus, initiating a “National COVID-19 Vaccination Day Immersion Program” in the least performing local government units across the Region for the 3-day national vaccination days;

**WHEREAS,** said “Immersion Program” was approved through RIATF Resolution No. 2021-22A on November 3, 2021 during its Joint RIATF-EID XII and RTF on COVID-19 XII Meeting as a strategy to increase vaccination coverage in the Region;

**WHEREAS,** the Joint RIATF-EID XII and RTF on COVID-19 XII member agencies were clustered into five (5) teams and were assigned to different vaccination sites in the provinces of Cotabato, Sarangani, South Cotabato, Sultan Kudarat, and General Santos City.;

**WHEREAS,** the Immersion Teams selflessly supported the successive 3-day National Vaccination Days and made remarkable accomplishments to include: the observance of the actual vaccination scenario, conduct public address and “recorda” in strategic areas of their assigned LGUs, conducted coordination meeting with local officials and functionaries in addressing the emerging issues and concerns at the local level, and recommend possible solutions to increase the percentage of vaccination coverage, among others;

**WHEREAS,** the Body recognizes that the success of the “Bayanihan, Bakunahan: Ligtas. Lakas. Buong Pinas” Campaign in Region XII is the concerted efforts extended by LGUs, other stakeholders, RIATF-EID XII, RTF Against COVID-19 XII member agencies, and the communities who manifested their strong support and commitment by pooling resources and stepping up to the call of improving our regional vaccination rate/performance;

**NOW, THEREFORE,** on motion of RD Akmad J. Usman of DBM XII, and seconded by RD Jeany Tedera of DOF-BLGF XII; **BE IT RESOLVED,** as it is hereby resolved, to commend the teams of the Immersion Program of the RIATF-EID XII and RTF Against COVID-19 XII during the three-day National COVID-19 Vaccination Days on November 29, 30, and December 1, 2021
