**RESOLUTION ENDORSING TO COMELEC XII THE LOCAL IATF RESOLUTION NO. 7 OF KIDAPAWAN CITY FOR APPROPRIATE ACTION**

- WHEREAS,** IATF Chairperson, Mayor Joseph A. Evangelista of Kidapawan City endorsed to the DILG Regional Office XII the copy of Inter-Agency Task Force Against COVID-19 Health Cluster Resolution No. 07-A, "Requesting the Regional Inter-agency Task Force on COVID-19 to request the Commission on Election to exempt any program/project that incentivizes the LGUs' vaccination roll-out strategies;
- WHEREAS,** the City of Kidapawan and City's Local Inter-Agency Task Force on COVID-19 grants incentives to the daily wage earners such as but not limited to drivers, market vendors, farm laborers and those similarly situated belongs to the 'NO WORK, NO PAY SECTOR' by giving them food packs and free fare going to the vaccination hubs with the goal to increase the vaccination accomplishment rate of the City;
- WHEREAS,** COMELEC Resolution No.10695 promulgated on February 10, 2021, in accordance with Section 104 of the Omnibus Election Code prescribing the Calendar of Activities and Periods of Certain Prohibited Acts in connection with the May 9, 2022 National and Local Elections, prohibits the act of giving





donations or gift in cash or in kind, etc. specifically starting February 8, 2022 (Tuesday) to May 9, 2022 (Monday);


**WHEREAS,** COMELEC as the authorized entity of the government to issue Certificate of Exemption to local government units and/or officials, the Body finds it necessary to endorse the Kidapawan City's Local Inter-Agency Task Force Against COVID-19 Health Cluster Resolution No. 07-A for the agency's appropriate action;


**NOW THEREFORE,** on motion of RD Usman J. Akmad of DBM XII and seconded by RD Teresita Socorro C. Ramos of NEDA XII; **BE IT RESOLVED,** as it is hereby **RESOLVED,** to **ENDORSE TO COMELEC XII THE LOCAL IATF RESOLUTION NO. 7 OF KIDAPAWAN CITY FOR APPROPRIATE ACTION.**


