RESOLUTION NO. 2020-021

**POLICY GUIDELINES AND RECOMMENDATIONS RELATIVE TO THE MANAGEMENT OF
CORONAVIRUS DISEASE (COVID-19) SITUATION IN REGION 12**

WHEREAS, President Rodrigo Roa Duterte, during his Public Address on July 15, 2020 declared the Provinces of Cotabato, South Cotabato, and Sultan Kudarat, and City of General Santos under Medium Risk Modified General Community Quarantine (MGCQ). Further, said areas are enjoined to implement zoning containment strategy and strict local action to decrease the case doubling rate. All other areas of the Region are classified as Low Risk MGCQ until July 31, 2020;

WHEREAS, DOH-CHD XII COVID-19 Tracker revealed that the Region, as of July 14, 2020, has one hundred ten (110) confirmed patients, two of whom died, fifty three (53) have fully recovered, and fifty five (55) are still on a quarantine. Among the active cases, fifty two (52) or 94.55.% are ROFs and LSIs while three have no travel history to high risk areas;

WHEREAS, DOH-CHD XII as the leader of Health Cluster, reported that as of July 14, 2020, the Region has a total of three-hundred forty nine (349) Contact Tracing Teams with four thousand thirty two (4,032) members. However, only 46.35% or one



thousand eight hundred sixty nine (1,869) are trained. As to Temporary Treatment Monitoring Facility, 74.54% or one thousand two hundred fifty six (1,256) of the one thousand six hundred eighty five (1,685) beds dedicated to COVID-19 patients are currently occupied;

WHEREAS, DILG Advisory dated June 22, 2020 which supports the IATF and NTF Memorandum Circular on the Application of the Zoning Containment Strategy for COVID-19 provides that the LGUs, through their Local Chief Executives, have the authority to determine and declare zoning classification and lockdown depending on preset parameters, including the existence of suspected, probable, or confirmed COVID-19 case. The authority may be exercised immediately to ensure timely response, subject to the review, assessment, and concurrence of the RIATF and RTF;

WHEREAS, RIATF-EID XII and RTF COVID-19, as the lead policy-making and implementing body for COVID-19 response in the Region, recognized the vital role of the LGUs and the Regional Line Agencies (RLAs) in institutionalizing the whole of government approach in containing and preventing the spread of the infection. It has acknowledged the best practices of both the LGUs and RLAs in ensuring that no local transmission occurs;

WHEREAS, during the Joint RIATF-EID XII and RTF COVID-19 Meeting, the Body discussed, strategized, and resolved emerging local issues and determined appropriate or future actions to avoid the further spreading of the virus;

NOW, THEREFORE, BE IT RESOLVED, as it is hereby resolved, that the Joint RIATF-EID XII-RTF-COVID-19 approved the following Resolutions:

- A. RESOLUTION DECLARING MORATORIUM FOR THE TRANSIT OF ROFs AND LSIs TO SARANGANI PROVINCE, GENERAL SANTOS CITY AND SOUTH COTABATO FOR A PERIOD OF 15 DAYS EFFECTIVE UPON THE APPROVAL OF THE NATIONAL TASK FORCE FOR COVID-19;
- B. RESOLUTION REGULATING COMMERCIAL INBOUND FLIGHTS TO GENERAL SANTOS CITY AIRPORT FOR APORs, ESSENTIAL TRAVELS, ROFs AND LSIs TO BE ACCOMMODATED EVERY MONDAYS AND THURSDAYS ONLY EFFECTIVE JULY 16, 2020 AND UNTIL THE REQUEST FOR MORATORIUM IS APPROVED BY THE NATIONAL TASK FORCE FOR COVID-19;
- C. RESOLUTION CONCURRING THE LOCALIZED LOCKDOWN OF SITIO AWAL, BRGY. LAMBA, BANGA, SOUTH COTABATO FROM JULY 14-18, 2020;
- D. RESOLUTION COMMENDING DENR XII FOR THE INITIATIVES UNDERTAKEN IN RESPONSE TO COVID-19;

- E. RESOLUTION ENJOINING LGUs OF REGION 12 TO FOCUS THEIR EFFORTS ON THE STRENGTHENING OF THEIR RESPECTIVE TEMPORARY TREATMENT MONITORING FACILITIES (TTMF);
- F. RESOLUTION REQUESTING LGUs OF REGION 12 TO REQUIRE ALL CONTACT TRACERS OF THEIR RESPECTIVE LGUs TO UNDERGO A CONTACT TRACING TRAINING AND TO ENCOURAGE MORE VOLUNTEERS TO PARTICIPATE IN THE CONTACT TRACING TRAINING BY DOH XII IN COORDINATION WITH DILG XII; AND
- G. RESOLUTION ENJOINING ALL LGUs OF REGION 12 TO STRICTLY ENFORCE THE HEALTH PROTOCOLS ON COVID-19 TO ENSURE COMPLIANCE OF THEIR RESPECTIVE CONSTITUENTS;
- H. AGREEMENTS:

RIATF-EID XII CONCERNS

- H.1. DILG XII to monitor progress of LGUs 1st Tranche of SAP Encoding from today onwards as requested by DSWD XII; and
- H.2. CORDS 12 to coordinate with CORDS BARMM on the concern about the Management of ROFs and LSIs and their observance of Health Protocols.

RTF COVID-19 CONCERNS

- H.3. Select members to convene for the review of the efficiency of COVID-19 response from April to Present on July 20, 2020;
- H.4. Follow-up the compliance of LGUs and establishments on the installation of CCTVs;
- H.5. Law and Order Cluster to strengthen the manning of checkpoints in regional borders;
- H.6. Concerned STGs to strengthen the process in the Management of the LSIs and ROFs at the airport, seaport and land;
- H.7. CAAP Gensan to find rooms to serve as temporary holding area for the LGU personnel who are waiting for the arrival of their ROFs, LSIs and APORs. Also, to prohibit private vehicles inside the airport terminal unless there is prior coordination; and
- H.8. NGAs to encourage APORs with travel history from high risk areas to undergo and complete the 14-day self-quarantine in accordance to the DOH Protocol and LGU Policies;




