## RESOLUTION NO. 2020-024-A

August 5, 2020

RESOLUTION REQUESTING AIRLINE COMPANIES TO BRIEF ALL PASSENGERS EN ROUTE TO GENERAL SANTOS AND COTABATO CITY REGARDING THE OBSERVANCE OF HEALTH AND LGU PROTOCOLS

WHEREAS, Per OMNIBUS GUIDELINES ON THE IMPLEMENTATION OF COMMUNITY QUARANTINE IN THE PHILIPPINES with Amendments as of July 16, 2020, the IATF approved the Implementation of the Modified Enhanced Community Quarantine (MECQ) including the zoning concept, corresponding qualification, and its phased response or intervention;



As of August 5, 2020, Region 12 is still under MGCQ status, hence, the following provisions under the Omnibus Guidelines shall be strictly observed, to wit:

- Minimum public health standards shall be complied with at all times for the duration of the MGCQ;
- The movement of all persons in areas placed under MGCQ shall be limited to accessing essential goods and services, for work in the offices or industries permitted to operate hereunder, and for other activities permitted under this Section. (As amended by Paragraph A(4)(a) of IATF Resolution No. 43, June 03, 2020);
- Mass gatherings such as but not limited to, movie screenings, concerts, sporting events, and other entertainment activities, religious services, and work conferences shall be allowed provided that participants shall be limited to fifty percent (50%) of the seating or venue capacity. (As amended by Paragraph A(4)(d) of IATF Resolution No. 43, June 03,2020)
- WHEREAS, the National Government initiated the Hatid Tulong Initiative (HTI) to provide transportation assistance for stranded people affected by the COVID-19 lockdown to return to their home provinces. However, LCEs observed that there are LSIs who did not avail of the HTI but instead opted to travel back home via Commercial Flights.

There were also reports that reached the RIATF-EID 12 that some passengers forget to observe the minimum health protocols during in-flight travels. Thus, increasing the risks of being infected.

- WHEREAS, per DOH COVID -19 Tracker, as of August 5, 2020, Region 12 recorded 310 confirmed COVID-19 cases. The increase of 25 COVID-19 cases in the span of 5 days (August 1-5, 2020) has been attributed to those travelling via commercial flights;
- **WHEREAS**, after thorough deliberation, the Body agreed to request airline companies to brief all passengers en route to General Santos City and Cotabato City to observe the minimum health standards and LGU health protocols and policies;
- NOW, THEREFORE, on motion of RD TERESITA SOCORRO C. RAMOS of NEDA XII and duly seconded by MR. KARL VINCENT QUIEPO of LGU General Santos City; BE IT RESOLVED, AS IT IS HEREBY RESOLVED to Request Airline Companies to Brief All Passengers En Route to General Santos and Cotabato City Regarding the Observance of Health and LGU Protocols;
- RESOLVED FURTHER, that a copy of this Resolution be forwarded to the Secretary Arthur P. Tugade of DoTR, CAAP General Santos City and Cotabato City, National IATF-EID, NTF COVID-19, Provincial Governors, City and Municipal Mayors of Region XII for their consideration and appropriate action. The same copy to be furnished to the members of the RIATF-EID XII & RTF COVID-19 for their information and or appropriate action.
