**RESOLUTION NO. 2020-024-B**

August 5, 2020

**RESOLUTION REQUESTING IATF TO REQUIRE THE AIRLINE COMPANIES TO INCLUDE IN INFLIGHT ANNOUNCEMENTS OF MINIMUM HEALTH PROTOCOLS AGAINST COVID-19**

**WHEREAS**, under the OMNIBUS GUIDELINES ON THE IMPLEMENTATION OF COMMUNITY QUARANTINE IN THE PHILIPPINES *with Amendments as of July 16, 2020*, the strict observance of a **Minimum public health standards** shall be complied with at all times regardless of the quarantine status of the LGUs, areas, or place;

**WHEREAS**, per DOH COVID -19 Tracker, as of August 5, 2020, the Philippines recorded a total of 115,980 COVID-19 cases. The increase in the COVID-19 cases has been attributed to several factors, such as but not limited to:

- Non-observance of the people to the DOH and LGU Health Standards and Protocols;
- Opening of the Economy;

- Allowing the movement of person except for leisure in areas placed under GCQ and MGCQ;
- Implementation of Hatid-Probinsya Program for LSIs and ROFs and Hatid Tulong Initiative for LSIs; and
- Permitting the road, rail, maritime, and aviation sectors of public transportation, and private transportation in areas placed under the GCQ and MGCQ;

**WHEREAS,** the LCEs of Region XII has raised their concerns regarding persons and LSIs travelling via Commercial Flights in various parts of the country. There were several instances where passengers neglect or forget to strictly observe the minimum health standards during air travels.

**WHEREAS,** after thorough deliberation, the Body agreed to request the IATF-EID to require airline companies to include in Inflight announcements the minimum health protocols to avoid the further spreading of the virus given the foregoing premises;



RAMOS of NEDA XII; **BE IT RESOLVED, AS IT IS HEREBY RESOLVED** to Request the IATF-EID to Require Airline Companies to Include in Inflight Announcements the Minimum Health Protocols;

**RESOLVED FURTHER,** that a copy of this Resolution be forwarded to the Secretary Arthur P. Tugade of DoTR, National IATF-EID, NTF COVID-19 for their consideration and appropriate action. The same copy to be furnished to the members of the RIATF-EID XII & RTF COVID-19, LCEs of Region XII for their information.


