RESOLUTION NO. 2021-02

January 27, 2021

**POLICY GUIDELINES AND RECOMMENDATIONS RELATIVE TO THE MANAGEMENT OF
CORONAVIRUS DISEASE (COVID-19) SITUATION IN REGION 12**

WHEREAS, a Memorandum from the Executive Secretary dated January 1, 2021 has classified the entire Region 12 under Modified General Community Quarantine (MGCQ) until January 31, 2021. The same directive requires that LGUs should continue to implement health promotion, localize community quarantine, and scale up their local health systems capacity;

WHEREAS, per Omnibus Guidelines on the Implementation of Community Quarantine in the Philippines dated January 21, 2021, the IATF approved the minimum protocols to be observed by areas under the Modified General Community Quarantine status. It specifically requires the strict implementation of the following: minimum public health standards shall be complied with at all times xxx; the movement of all persons in areas under MGCQ shall be limited to accessing essential goods and services, for work in the offices or industries permitted to operate xxx; any person below ten (10) years old, those who are over sixty-five (65) years of age and above, those with immunodeficiency, comorbidity, or other health risks, and pregnant women shall be required to remain in their residences xxx; and mass gatherings such as but not limited to, movie screening, concerts, sporting events, and other entertainment activities, religious services and work conferences shall

be allowed provided that participants shall be limited to 50% of the seating or venue capacity;

WHEREAS, DOH-CHD XII reported that as of January 26, 2021, the Region has a total of 4,449 confirmed cases of whom 3,823 have fully recovered, 162 deaths and 463 are currently under quarantine or confined in the referral hospitals. A total of 484 cases was added in a span of fourteen days or an average of 35 cases per day;

WHEREAS, OWWA XII reported that as of January 21, 2021, the One Stop Shop for the Management of Returning Overseas Filipinos (MROF) has assisted 20,029 ROFs. As of January 25, 2021, it recorded a total of 131 ROFs with history of travel to red-flagged countries;

WHEREAS, a facebook page named as Region12 Inter Agency Task Force was created on June 10, 2020. The page is being maintained by NEDA XII. It also serves as a platform to disseminate information and to answer concerns about COVID-19 response operations;

WHEREAS, DILG Memorandum dated July 23, 2020 directed all LGUs to implement existing national laws and/or enact/amend local ordinances that shall ensure the compliance with the Omnibus Guidelines and minimum public health standards prescribed by DOH within their respective jurisdictions. Further, LGUs are directed to include penal provisions for those who will violate the existing policies;

WHEREAS, DTI-DOLE Joint Memorandum Circular No. 20-04-A series of 2020 directed all permitted industries and workplaces to open under MGCQ and to strictly comply with the following health protocols: mandatory wearing of face masks and face shields; strict observance of physical distancing; and presence of disinfection area;

WHEREAS, during the 29th Joint RIATF-EID XII and RTF COVID-19 XII Meeting, the Body discussed, strategized, and resolved emerging local issues and determined appropriate or future actions to avoid the further spreading of the virus;

NOW, THEREFORE, BE IT RESOLVED, as it is hereby resolved, that the Joint RIATF-EID XII- RTF-COVID-19 XII approved the following Resolutions:

- A. RESOLUTION ENJOINING ALL LGUs OF REGION 12 TO POST THEIR CURRENT HEALTH PROTOCOLS AND QUARANTINE CLASSIFICATION IN VARIOUS SOCIAL MEDIA PLATFORMS FOR THE GUIDANCE OF ROFs AND RETURNING RESIDENTS;
- B. RESOLUTION UTILIZING THE FACEBOOK PAGE CREATED BY NEDA 12 AS COMMON POSTING PLATFORM OF LGUs OF REGION 12 ON THE CURRENT HEALTH PROTOCOLS AND QUARANTINE CLASSIFICATIONS FOR THE GUIDANCE OF RETURNING OFWs AND RETURNING RESIDENTS; AND
- C. RESOLUTION ENJOINING LGUs OF REGION 12 TO CONDUCT SURPRISE INSPECTIONS OF ALL BUSINESS ESTABLISHMENTS IN THEIR AREAS TO MONITOR STATUS OF ADHERENCE TO MINIMUM




HEALTH PROTOCOLS AND TO ENFORCE COMPLIANCE OF ALL CONCERNED

RESOLVED FURTHER, that a copy of this Resolution be forwarded to the IATF-EID and NTF COVID-19 for information and support.
