**RESOLUTION NO. 2021-06**

March 24, 2021

**RESOLUTION INDORSING TO IATF-EID THE REQUEST OF SOUTH COTABATO, SARANGANI, AND TACURONG CITY, SULTAN KUDARAT TO CONSIDER THEIR APPEAL FOR THE IMPOSITION OF 7-DAY MANDATORY QUARANTINE AND ANTIGEN TESTING ON THE 3<sup>rd</sup> TO 5<sup>th</sup> DAY OF ARRIVAL OF TRAVELERS COMING FROM GCQ AREAS**

**WHEREAS**, the Omnibus Guidelines on the Implementation of Community Quarantine in the Philippines dated February 18, 2021 approved by the IATF provided for the minimum protocols to be observed in areas under the Modified General Community Quarantine status requiring the strict implementation of the following: minimum public health standards shall be complied with at all times xxx; and the movement of all persons in areas under MGCQ shall be limited to accessing essential goods and services, for work in the offices or industries permitted to operate xxx;

**WHEREAS**, DOH-CHD XII reported that as of March 23, 2021, the Region has a total of 5,961 confirmed cases of whom 5,538 have fully recovered, 216 deaths and 205 are currently under quarantine or confined in the referral hospitals. A total of 138 cases was recorded in a span of seven days or an average of 20 cases per day;

**WHEREAS**, IATF-EID Resolution No. 101 dated February 26, 2021 provides that testing shall not be mandatory for travelers except if the LGU of destination will require testing as a requirement prior to travel which



shall be limited to RT-PCR, and no traveler shall be required to undergo quarantine unless they exhibit symptoms upon arrival at the LGU of destination;


**WHEREAS**, during the meeting of the Joint RIATF-EID XII and RTF-COVID 19, some Local Chief Executives appealed that they be given authority to impose stricter protocols among returning residents from high-risk areas. With the increasing number of passengers entering the Region, this has posed a higher probability of spreading the COVID-19. Consequently, they recommended that those non-APORs with non-essential travels be subjected to at least seven-day quarantine and antigen tests to be shouldered by the LGU of destination;

**NOW, THEREFORE**, on motion of RD Macario D. Gonzaga of LTO XII and seconded by RD Teresita Soccoro C. Ramos of NEDA XII; **BE IT RESOLVED**, as it is hereby resolved, to Indorse to IATF-EID the Request of South Cotabato, Sarangani, and Tacurong City, Sultan Kudarat to Consider their Appeal for the Imposition of 7-Day Mandatory Quarantine and Antigen Testing on the 3<sup>rd</sup> to 5<sup>th</sup> Day of Arrival of Travelers Coming from GCQ Areas;

**RESOLVED FURTHER**, that a copy of this Resolution be forwarded to the IATF-EID and NTF COVID-19 for their information and support. The same copy shall be furnished to RIATF-EID XII and RTF COVID-19 XII members for their information.


