**RESOLUTION NO. 2021-09**

**RESOLUTION REITERATING TO ALL LGUs TO SUPPORT THE ESTABLISHMENT OF ONE HOSPITAL COMMAND AND TO ISSUE POLICY THROUGH EXECUTIVE ORDER AMONG OTHERS IN THEIR RESPECTIVE AOR**

**WHEREAS**, DOH Department Order No. 2020-0653 dated October 21, 2020 provides the guidelines in establishing One Hospital Command Center. The One Hospital Command Center shall be responsible in the following: handle all calls from the CHDs, LGUs EOCs, and institutions related to the referral to licensed COVID-19 testing laboratories and medical dispatch of COVID-19 patients to the appropriate hospitals, TTMFs, and other health facilities; coordinate with the appropriate receiving facility and monitor the referral status until admitted or discharged xxx; and utilize available data for referrals to ensure provision of appropriate management of COVID-19 patients;

**WHEREAS**, DOH-CHD XII on October 28, 2020 released the Regional Order No. 0020 s. 2020 entitled, "Regional Guidelines on the Establishment and Institutionalization of the One Hospital Command System in SOCCSKSARGEN Region". The same guidelines require the Provinces to establish One Hospital Command System Operation Center preferably in a Level 1 or Level 2 government hospital to serve as nerve center of OHCS;

**WHEREAS**, the Body has passed Resolution No. 2020-037-C on November 11, 2020 which urges all the Provincial LGUs to lead in the organization of the One Hospital Command System. It aims to ensure a comprehensive and coordinated



response to the COVID-19 pandemic by establishing an effective and efficient health facility referral system;


**NOW, THEREFORE**, on motion of RD Macario D. Gonzaga of LTO XII and seconded by RD Aristides Concepcion Tan of DOH-CHD XII and; **BE IT RESOLVED**, as it is hereby resolved, to Reiterate to All LGUs to Support the Establishment of One Hospital Command and to Issue Policy Through Executive Order Among Others in their Respective AOR;

**RESOLVED FURTHER**, that a copy of this Resolution be forwarded to the IATF-MEID and NTF COVID-19 for their information and support. The same copy shall be furnished to RIATF-EID XII and RTF COVID-19 XII members for their information, and all Local Government Units of Region XII for their appropriate action.


